THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 284-2005

To authorize the expropriation of certain interest in lands for the widening of Goreway Drive

Section 6 of the Municipal Act 2001 authorizes the Council of every corporation to pass a by-law for acquiring or expropriating any land required for the purposes of the corporation. The Council of The Corporation of the City of Brampton has determined that it is necessary and in the interest of The Corporation of the City of Brampton to expropriate the interest in lands herein described for the purposes of widening Goreway Drive, creating 0.3 metre reserves and establishing easements for the installation, repair and replacement of necessary guy wires and anchors to support the construction, installation, repair and replacement of lines of electric power and service wires to be located along Goreway Drive as widened.

NOW THEREFORE The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**

1. The expropriation of the lands in the City of Brampton, shown on the attached schedule "A", for the purposes of road widening, 0.3 metre reserves and easements for the installation, repair and replacement of necessary guy wires and anchors to support the construction, installation, repair and replacement of lines of electric power and service wires to be located along Goreway Drive as widened is hereby authorized.
2. The Mayor and City Clerk are hereby authorized to execute on behalf of The Corporation of the City of Brampton as expropriating authority, all notices, applications, advertisements and other documents required by the Expropriations Act, R.S.O. 1990, c.E.26, as amended, that in the opinion of the City Solicitor are necessary in order to effect the expropriations of the said interest in lands.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 26 day of September, 2005.

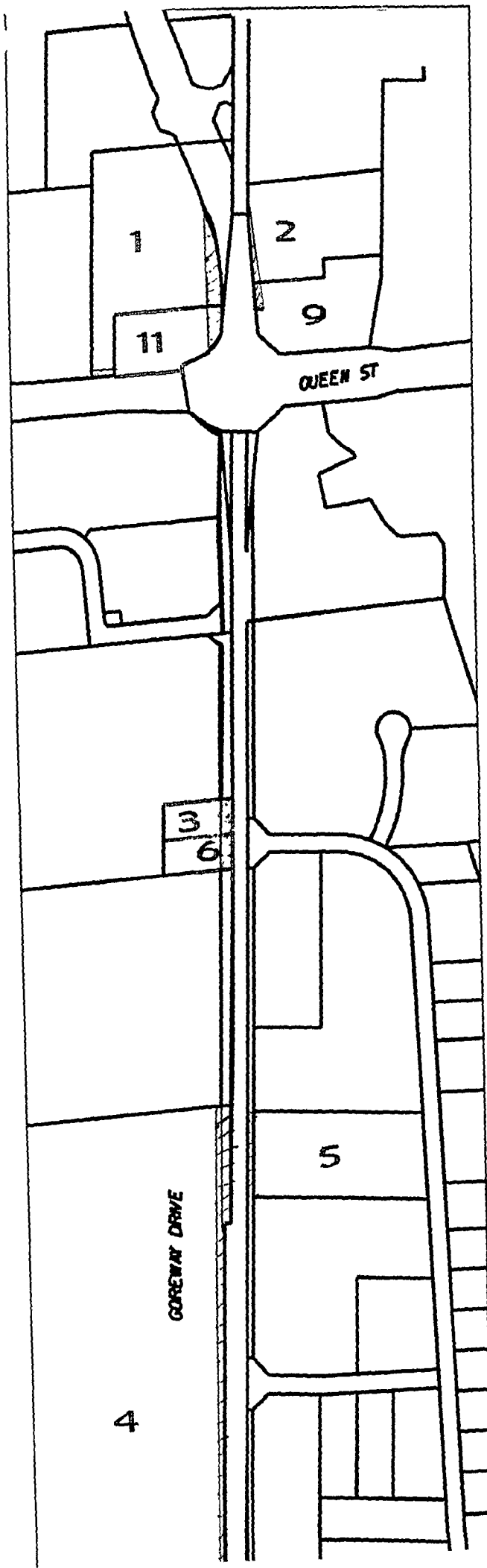
