A By-law to amend Licensing By-law 1-2002 to Increase Fees for Mobile and Stationary Business Licenses

WHEREAS By-law 1-2002 was passed pursuant to the *Municipal Act, 2001,* respecting the issuance of Licenses in the City of Brampton;

AND WHEREAS Schedule A to Licensing By-law 1-2002 establishes fees for licences;

AND WHEREAS pursuant to Council Resolution **C267-2008**, approved by City Council on November 26, 2008, it is deemed appropriate to amend fees related to Mobile and Stationary Business Licenses;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That Licensing By-law 1-2002, as amended is further amended by deleting Appendix A, Fee Schedule, and substituting therefore Schedule A attached hereto, effective as of the 2009 Licensing Period.

\*These rates, except for fees for Lottery Licenses, shall automatically increase and be rounded up to the nearest dollar on the first day of January in each year by the percentage increase in the All Items Index of the Consumer Price Index (not seasonally adjusted) for the Toronto Census Metropolitan Area, published by Statistics Canada, during the 12-month period ending on September 30 in the year immediately preceding the rate increase date.
