The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 151-88, as amended, is hereby further amended:
 - (1) by changing on Sheet 22 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY D SECTION 1129 (R1D SECTION 1129), RESIDENTIAL SINGLE FAMILY C SECTION 1130 (R1C SECTION 1130), RESIDENTIAL TWO FAMILY A SECTION 1131 (R2A SECTION 1131) and OPEN SPACE (OS).

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL, this 2002.




ZONE BOUNDARY

DECLARATION

I, LEONARD JOSEPH MIKULICH, of the City of Brampton, Region of Peel, DO SOLEMNLY DECLARE THAT:

- 1. I am the Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
- 2. By-law 296-2002 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 16th day of October, 2002, to adopt Amendment Number OP93-198 to the 1993 Official Plan of the City of Brampton Planning Area.
- 3. By-law 297-2002 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 16th day of October, 2002, to amend Comprehensive Zoning By-law 151-88, as amended.
- 4. Written notice of By-law 296-2002 as required by section 17(23) and By-law 297-2002 as required by section 34(18) of the *Planning Act* was given on the 29th day of October, 2002, in the manner and in the form and to the persons and agencies prescribed by the Planning Act, R.S.O. 1990 as amended.
- 5. No notice of appeal was filed under sections 17(24) and 34(19) of the *Planning Act* on or before the final date for filing objections.
- 6. In all other respects this Official Plan Amendment has been processed in accordance with all of the Planning Act requirements including regulations for notice.
- 7. OP93-198 is deemed to have come into effect on the 19th day of November, 2002, in accordance with Section 17(27) of the *Planning Act*, R.S.O. 1990, as amended.
