The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 56-83, as amended, is hereby further amended:


(1) by adding to section 529.1 thereof, the following:


“(7) a personal service shop.”


(2) by adding to section 529.2 thereof, the following:

“(14) the maximum gross floor area of devoted to a personal service shop shall be 145 square metres and parking for a personal service shop shall be provided at a ratio of 1 space per 23 square metres of gross floor area devoted to a personal service shop use.”

DECLARATION


I, LEONARD JOSEPH MIKULICH, of the City of Brampton, Region of Peel, DO SOLEMNLY DECLARE THAT:

1. I am the Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
2. By-law 301-2002 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 16th day of October, 2002, to adopt Amendment Number OP93-199 to the 1993 Official Plan of the City of Brampton Planning Area.
3. By-law 302-2002 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 16th day of October, 2002, to amend Comprehensive Zoning By-law 56-83, as amended.
4. Written notice of By-law 301-2002 as required by section 17(23) and By-law 302-2002 as required by section 34(18) of the *Planning Act* was given on the 29th day of October, 2002, in the manner and in the form and to the persons and agencies prescribed by the *Planning Act*, R.S.O. 1990 as amended.
5. No notice of appeal was filed under sections 17(24) and 34(19) of the *Planning Act* on or before the final date for filing objections.
6. In all other respects this Official Plan Amendment has been processed in accordance with all of the *Planning Act* requirements including regulations for notice.
7. OP93-199 is deemed to have come into effect on the 19th day of November, 2002, in accordance with Section 17(27) of the *Planning Act*, R.S.O. 1990, as amended.
