# BY-LAW

*Number* 306-86

To further amend By-law 149-83  
(municipal parking lots)

---

WHEREAS The Corporation of the City of Brampton has developed a municipal parking lot on George Street North, north of Nelson Street West;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 149-83, as amended, being a by-law to regulate, supervise and govern the parking of vehicles on municipal parking lots, is hereby further amended as follows:

(1) Section 2 is amended:

(a) by deleting the word "and" from subsection 3;

(b) by replacing the period with a comma at the end of subsection 4 and by adding the word "and" thereto; and

(c) by adding subsection (5) as follows:

"(5) to establish procedures for the issuance of monthly parking permits for the parking lots set out in Schedules B, C and D of this by-law."

(2) Section 5(1) is amended by deleting the words "Schedules A, B and C" from the second line, and by substituting therefor the words "Schedules A, B, C and D."

(3) Section 7(1) is amended

(a) by deleting the word "times" from the third line and by substituting therefor the words "hours of operation"; and

(b) by deleting the words "Schedule B" from the fourth line and by substituting therefor the words "Schedule A".

(4) Section 10 is amended by deleting the words "Schedules B and C" from the third line, and by substituting therefor the words "Schedules B, C and D".

(5) Section 11 is hereby repealed and the following is substituted therefor:

"11 (1) No person shall park a motor vehicle in a parking lot listed in Schedule D during the times set out in Schedule D without having obtained a monthly permit to do so in accordance with section 10.

(2) The permit shall, while the motor vehicle is parking in or on any parking lot listed in Schedule B or Schedule D, be placed inside the windshield of the motor vehicle in such position that the writing and markings on the permit face outward and can be easily seen from outside the motor vehicle."

(6) Schedule A is hereby amended:

(a) by deleting the words "George Street North Parking Lot" from Column 1, and by substituting therefor the words "McMurchy Lane Parking Lot"; and

(b) by deleting the words "Hours of Operation for the George Street North Parking Lot" and by substituting therefor the words "Hours of Operation for the McMurchy Lane Parking Lot".

(7) Schedule D is hereby added to this by-law after Schedule C. Schedule D is to read as follows:

Between the hours of 8 o'clock a.m. and 6:00 o'clock p.m., Monday to Friday inclusive.

(8) Schedule A to this by-law is hereby added as Plan 5, part of Schedule D to By-law Number 149-83.
