Number 309-2003

To amend By-law 93-93,

RATE OF SPEED, NO PARKING, NO STOPPING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
 - (1) by deleting from Schedule X thereto the following item:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
McLaughlin Road	60	Queen Street and the southerly limit of the City of Brampton	Anytime

(2) by adding to Schedule X thereto the following items:

McLaughlin Road	60	A point 241 metres north of Harold Street and the southerly limit of the City of Brampton	Anytime

(3) by deleting from Schedule XIV thereto the following items:
