To amend By-law 270-2004, as amended

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 270-2004, as amended, is hereby further amended:

(1) by changing on Sheet 20 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law:

FROM	TO
AGRICULTURAL (A)	INSTITUTIONAL ONE SECTION 1892 (I1 Section 1892).

(2) by adding thereto, the following sections:

1892 The lands designated I1 - Section 1892 of Schedule A to this By-law:

1892.1 shall only be used for the following purposes:

i. A Place of Worship


1892.2 shall be subject to the following requirements and restrictions:

(1) Front Yard Landscape Strip

6.0 metres


1892.3 shall also be subject to the requirements and restrictions of the Institutional One (I1) zone and all the general provisions of this by-law, which are not in conflict with the ones set out in section 1892.2.

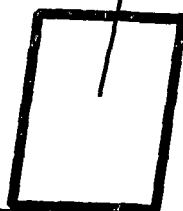

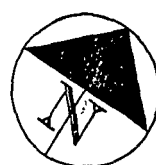


MISSISSAUGA ROAD

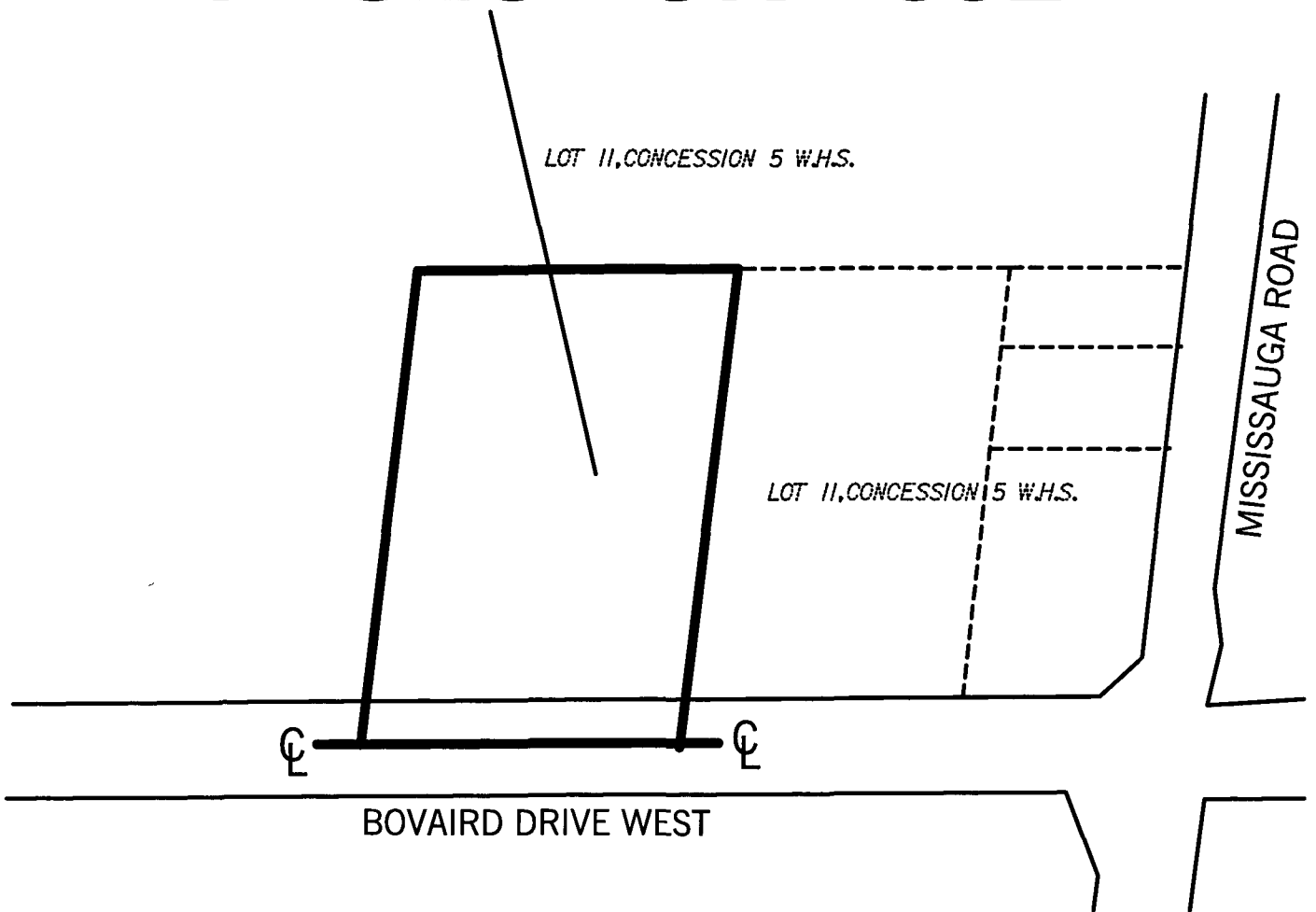

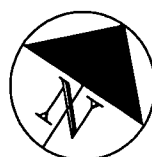


DECLARATION


I, Leonard Joseph Mikulich of the Town of Shelburne, in the County of Dufferin, do solemnly declare that:

1. I am the Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
2. By-law 313-2005 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 12th day of October, 2005, to adopt Amendment Number OP93-252 to the 1993 Official Plan of the City of Brampton Planning Area.
3. By-law 314-2005 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 12th day of October, 2005, to amend Zoning By-law 270-2004, as amended.
4. Written notice of By-law 313-2005 as required by section 17(23) and By-law 314-2005 as required by section 34(18) of the *Planning Act* was given on the 26th day of October, 2005, in the manner and in the form and to the persons and agencies prescribed by the *Planning Act*, R.S.O. 1990 as amended.
5. No notice of appeal was filed under section 17(24) and section 34(19) of the *Planning Act* on or before the final date for filing objections.
6. In all other respects this Official Plan Amendment has been processed in accordance with all of the *Planning Act* requirements including regulations for notice.
7. OP93-252 is deemed to have come into effect on the 16th day of November, 2005, in accordance with Section 17(27) of the *Planning Act*, R.S.O. 1990, as amended.
