MEMORANDUM OF AGREEMENT made in duplicate this 12Hday of levente , 1977.

BETWEEN:

MANSFIELD FOOTWEAR LIMITED hereinafter called the 'Owner'

OF THE FIRST PART

AND

THE CORPORATION OF THE CITY OF BRAMPTON hereinafter called the 'City'

OF THE SECOND PART

WHEREAS the Owner is the owner of the lands shown on Schedule "A" annexed hereto;

AND WHEREAS the Owner has applied to the City of Brampton for a rezoning to permit certain limited retail uses on the lands shown on Schedule "A";

AND WHEREAS the City is of the opinion that the said rezoning would not be proper and in the public interest unless the matters set out in this agreement are provided for.

NOW THEREFORE THIS AGREEMENT WITNESSETE that in consideration of the covenants hereinafter contained and in consideration of the City approving and recommending to the appropriate authorities the approval of the plan for registration, the parties hereto agree each with the other as follows:

The lands described as Part of Lot 6, Concession 1, West of Hurontario Street and more particularly shown on Schedule "A" annexed hereto shall be developed and maintained only in accordance with Schedule "A" annexed hereto, provided the zoning by-law to permit limited retail uses on the said lands receives Ontario Municipal Board approval. The Owner agrees that customer parking shall only be permitted in the areas designated on Schedule "A" annexed hereto and that a chain or gate and signs satisfactory to the Building and Zoning Co-ordinator and the Director of Planning of the City of 'Brampton shall be provided to prevent customer parking on railway property.

The Owner also agrees to install a sign satisfactory to the Building and Zoning Co-ordinator at the Mill Street access indicating that the access is for emergency access only and the Owner also agrees that signs shall be installed in front of the Mill Street entrance to direct customer access and parking at the Joseph Street access.

The Owner agrees to remove the existing fence along Joseph Street and to clean up the site and to replace the fence with a new hedge or fence to the satisfaction of the City Director of Parks and Recreation.

The Owner agrees that following Ontario Municipal Board approval of the by-law to permit limited retail uses, the Owner shall maintain the site in accordance with Schedule "A" and in a clean state.

The covenants, agreements, conditions and undertakings herein contained on the part of the Owner shall run with the Successors & Assigns lands and shall be binding upon it and upon its successors and assigns and shall be appurtenant to the adjoining highway in the ownership of the City of Brampton and/or the Region of Peel.



The Owner agrees that this agreement may be registered against the title to the lands shown on Schedule "A" or lodged in the Registry Office as a deposit against the said title, and the Owner agrees to execute such further assurances as may be requisite to enable compliance with this provision.
