A By-law to amend User Fee By-law 380-2003, as amended

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001*, s. 391 (1) to impose fees or charges;



- 1. That By-law 380-2003 is hereby amended by replacing Schedule G, Transit Division Fees/Charges, Works and Transportation Department, with the Schedule set out in Appendix 1 to this by-law.
- 2. This by-law shall come into force and effect as of January 1, 2013.
