Number 322-2005

To amend Zoning By-law 270-2004, as amended

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 270-2004, as amended, is hereby further amended:
 - (1) by changing on Schedule A thereto of the By-law, the zoning designation of the lands shown outlined on Schedule A attached to this by-law

from	to
AGRICULTURAL SECTION 367 (A-SECTION 367)	RESIDENTIAL SINGLE DETACHED C SECTION 1279 (RIC- SECTION 1279) and, RESIDENTIAL SINGLE DETACHED C SECTION 1350 (RIC- SECTION 1350).
 - (2) by adding thereto the following sections:

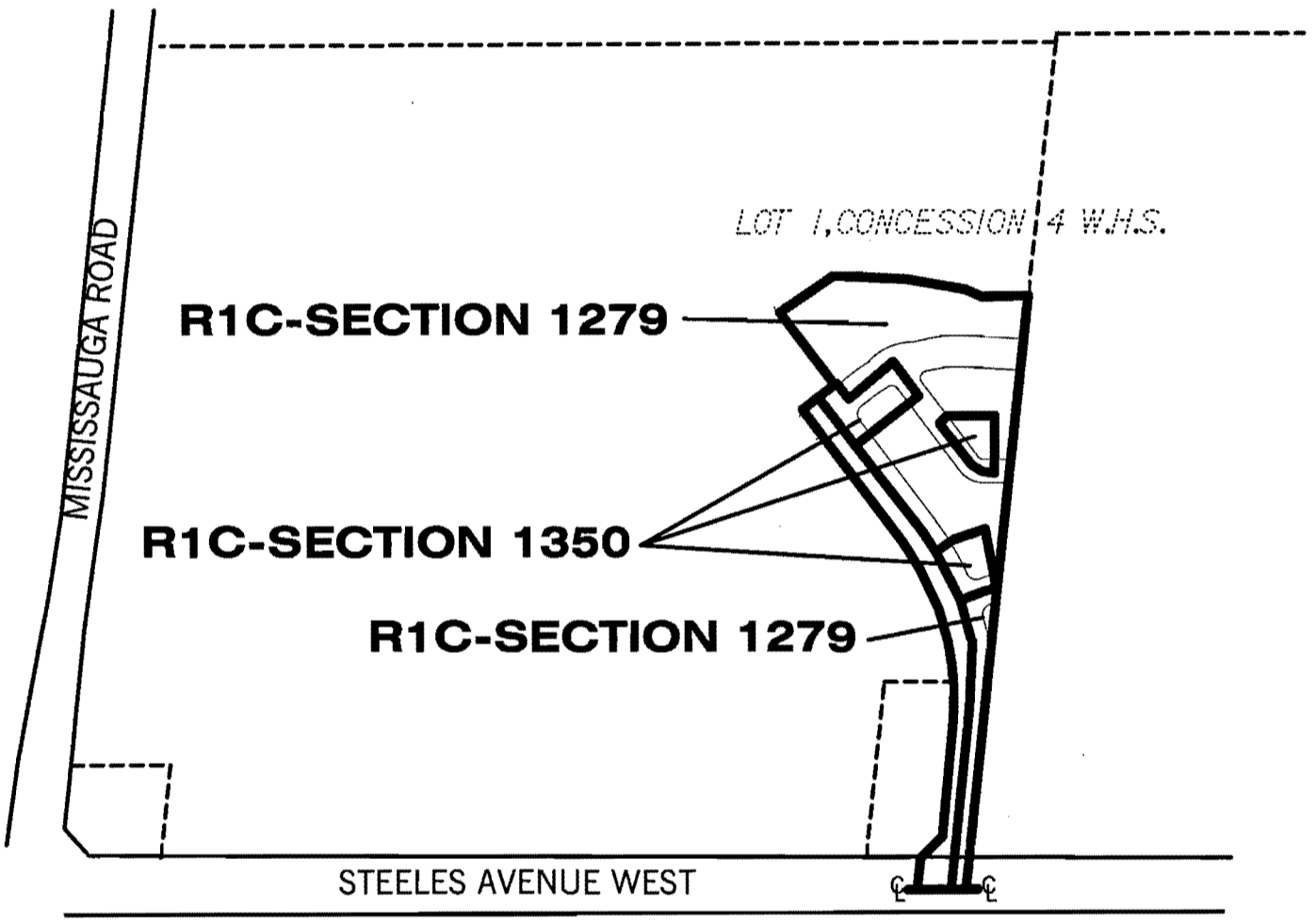
“1350 The lands designated RIC- Section 1350 of Schedule A to this by-law:

1350.1 shall only be used for the purposes permitted in an RIC zone.



1350.2 shall be subject to the following requirements and restrictions:

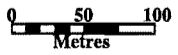
 - (a) the requirements and restrictions as set out in an RIC-Section 1279 zone.
 - (b) Minimum Exterior Side Yard Width: 4.5 metres.

1350.3 shall also be subject to the requirements and restrictions relating to the RIC-Section 1279 zone and all the general provisions of this by-law, which are not in conflict with those set out in section 1350.2.”

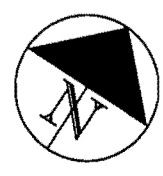


LEGEND

PART LOT 1, CONCESSION 4 W.H.S.



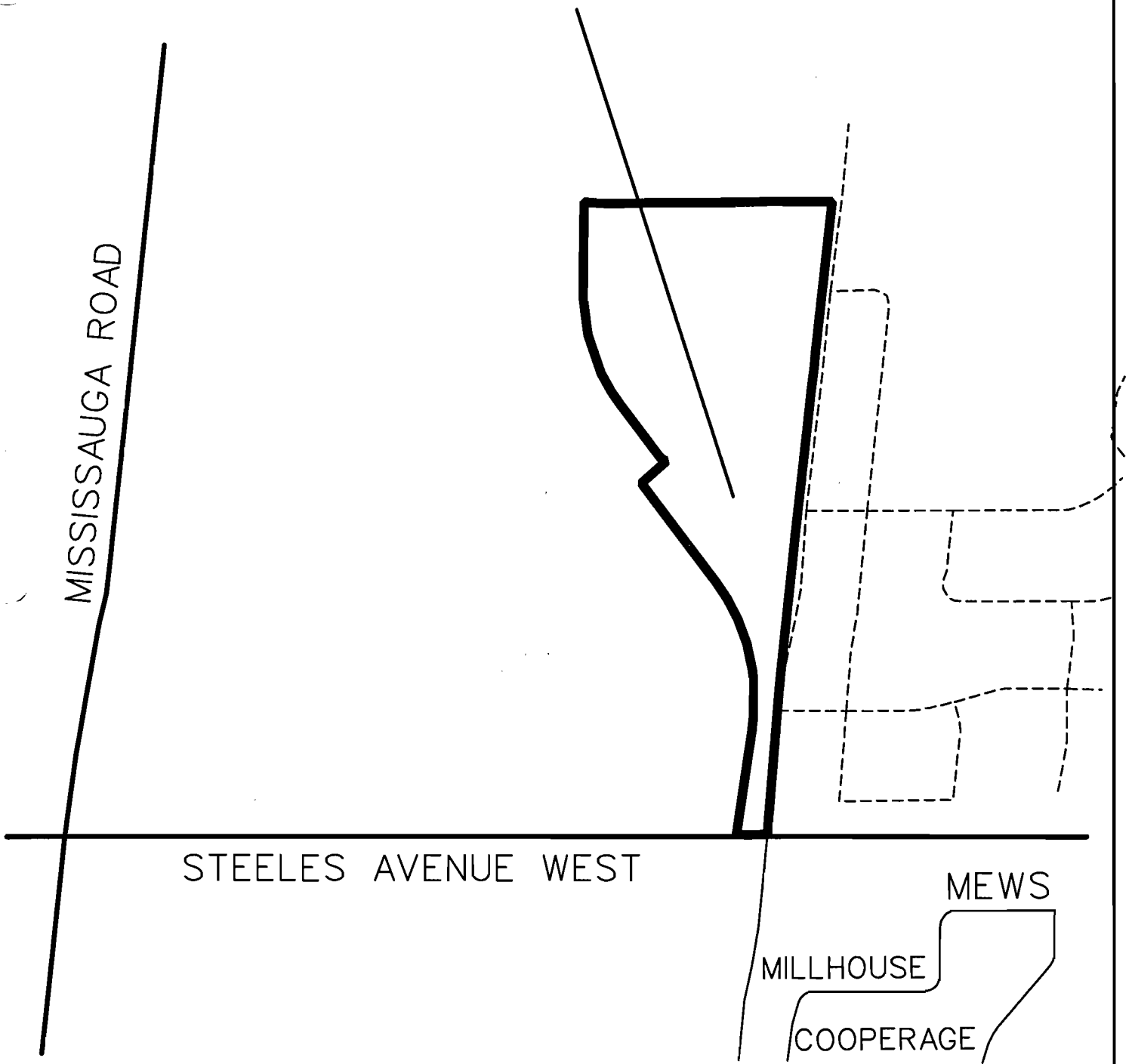

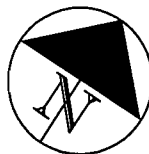
