BY-LAW

To accept and assume as public highways certain lands shown on Registered Plan M-112

WHEREAS it is deemed expedient to accept and assume certain streets shown on Registered Plan M-112 as public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The lands dedicated as public highways and described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 18th day of November, 1985.


SCHEDULE A TO BY-LA337-85
