An interim control by-law applicable to part of the area subject to By-law 861

The council of the Corporation of the City of Brampton ENACTS as follows:

- 1. Subject to section 2 of this by-law, the lands which are subject to By-law 861 (being the lands within the boundaries of the former Township of Chinguacousy) and within any <u>industrial</u> zone <u>shall not</u> be used for the purposes permitted by section 17(3) [commercial buildings in industrial zones] of By-law 861, as amended.
- 2. Section 1 shall not apply to prevent the use of
 - (1) the part of Lot 1, Concession 3, E.H.S., in the geographic Township of Chinguacousy, designated as Part 1 on reference plan 43R-11765, for any of the purposes permitted by section 17(3) of By-law 861, as amended.
 - (2) the part of Lot 4, Concession 3, E.H.S., in the geographic Township of Chinguacousy, identified as the "subject lands" on Schedule A to this by-law, for any of the purposes permitted by section 17(3) of By-law 861, as amended, and
 - (3) the part of Lot 11, Concession 1, W.H.S., in the geographic Township of Chinguacousy, identified as the "subject lands" on Schedule B to this by-law, for any of the purposes permitted by section 17(3) of By-law 861, as amended.
- 3. Subject to section 4 of this by-law, the lands which are subject to By-law 861 (being the lands within the boundaries of the former Township of Chinguacousy) and within any agricultural zone shall not be used for the purposes permitted by the following sections of By-law 861, as amended:
 - (1) section 20(5) [educational use]
 - (2) section 20(6) [church]
 - (3) section 20(7) [hospital or clinic]


- (4) section 20A 1.(5) [educational use]
- (5) section 20A 1.(6) [church]
- (6) section 20A 1.(7) [hospital or clinic]
- (7) section 20A 1.(12) [nursing home]
- 4. Section 3 shall not apply to prevent the use of the part of Lot 11, Concession 4, E.H.S., in the geographic Township of Chinguacousy, designated as Part 1 on reference plan 43R-11555, for a church.
- 5. This by-law shall be in effect from 18 November 1985 until 17 November 1986.




