To accept and assume as public highways certain lands shown on Registered Plan M-387

WHEREAS it is deemed expedient to accept and assume certain lands shown on Registered Plan M-387 as public highways;

NOW THEREFORE the council of The Corporation of the City of Brampton hereby ENACTS AS FOLLOWS:

1. The streets and street widenings shown on Registered Plan M-387 and dedicated as public highways, and described in Schedule A to this by-law, are hereby accepted and assumed as part of the public highway system of the City of Brampton.
