A By-law to amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), PERMIT ONLY OPERATION (Schedule XXVIII), DESIGNATED TURNING LANES (Schedule VI), BARRIER CONTROLLED (Schedule XXVII), HEAVY TRUCKS (Schedule XI) NO STOPPING (Schedule XV) and FIRE ROUTES (Schedule XXII)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

Ariel Road	The east limit of Baycliffe Crescent (westerly intersection) and the west limit of Baycliffe Crescent (easterly intersection)
Allegro Drive	The west limit of the intersection of Allegro Drive with itself and the south limit of Allegro Drive




