A By-law to Amend By-law 191-2003
being a By-law to Appoint a Chief Building
Official and Inspectors for the Enforcement
of the Building Code Act and Regulations

WHEREAS section 3(2); of the *Building Code Act*, S.O. 1992 requires the Council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the purposes of the enforcement of the *Building Code Act*;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. Section 3 of by-law 191-2003 is hereby amended as follows:
 - (1) P. Cheeseman is deleted from the list.
2. C. House and E. Balestreri are appointed as inspectors for the enforcement of the Building Code Act (and regulations made thereunder) in the City of Brampton.
3. Attached hereto as Schedule "A" is an up-to-date list of inspectors' names.
