shown on Registered Plan 43M-523 as public highways;

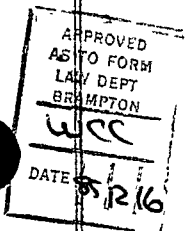
NOW THEREFORE the council of The Corporation of the City of
