To Appoint Municipal By-law
Enforcement Officers and to
Repeal By-law 337-2001

WHEREAS paragraph 45 of section 207 of the Municipal Act (R.S.O. 1990, c. M.45, as amended) authorizes the appointment of such officers and servants as may be necessary for the purposes of the Municipal Corporation;

AND WHEREAS section 15 of the Police Services Act (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;


2. By-law 337-2001 is hereby repealed.


