Number 365-2012

A By-law to amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), FIRE ROUTES (Schedule XXII), U-TURNS (Schedule II), PROHIBITED TURNS (Schedule VII) and RATE OF SPEED (Schedule X)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:
