COVID-19 has been challenging for all of us and I want to reassure you that I have and will continue to work hard for you and your families during these unprecedented times.

Keeping our community safe remains a priority, and I am happy to share that we have made progress on key initiatives. Thanks to you, we successfully campaigned against a retail cannabis store in the heart of a residential neighbourhood. In addition, the City of Brampton and Region of Peel supported my request for a community police station in Brampton's east end, which is currently in the planning phase.

For the third year in a row, Brampton achieved a ZERO percent property tax increase. COVID-19 has not only been tough on our health, but also our economy, and this means more of your hard earned money will remain with you.

Finally, I am proud to announce Peel Memorial will be expanded to a FULL hospital, and Ryerson received a planning grant for a new medical school.

As this year progresses, I will continue to advocate for more vaccines, better transit, and further economic support from the provincial and federal governments.


COVID-19 UPDATES AND VACCINATION ROLLOUT

The new exterior building signage for Save Max Sports Centre (formally Brampton Soccer Centre) will be up soon. The City retains full ownership and operation of the facility, and besides a new name, a new free afterschool basketball program for youth will be offered at the location – made possible through the naming rights agreement.

Brampton has taken a progressive approach to finding alternative revenue sources to offset the tax burden on residents. The sale of naming rights brings more money to the facility to improve the delivery of programs and services, directly benefiting residents using that facility.

Now that the weather is warming up, it means barbeque season is upon us. Follow these tips to make this a fire-safe barbeque season:

- Clean, inspect and test all connection lines
- · Never leave a lit BBQ unattended
- · Never BBQ inside your garage
- Do not place the BBQ close to anything that can burn
- To avoid a fire, make sure grease does not build up on the burners or at the base of the BBQ
- · Keep children and pets a safe distance away
- Turn off all fuel sources after use and leave the lid open to let it cool before you safely store it away

YARD MAINTENANCE

By-laws help everyone enjoy a clean, safe neighbourhood and shared public spaces. On your private property, keep grass cut to 20 cm (8 inches) or shorter, and trim trees and hedges to avoid overgrowth. Remove stagnant water (often accumulated in wading pools, pool covers, buckets, etc.), and be sure not to store damaged or partially working items or debris on your property.

USING FIREWORKS FOR VICTORIA DAY, CANADA DAY, DIWALI AND NEW YEAR'S EVE?



Only short-range fireworks, those that tend to travel less than three metres (10 feet) when set off, are allowed on Victoria Day, Canada Day, Diwali and New Year's Eve. Examples include fountains, wheels, ground spinners, sparklers. All other fireworks are banned in Brampton, and no fireworks are allowed on sidewalks, at schools, parks and other public properties.

SAFETY TIPS:



Keep a container of water or a hose line that's filled with water available to extinguish fireworks



Never light a firework or hold a lit firework in your hand, other than a sparkler





After using sparklers, place them in a container of water to fully cool before disposal




ACCESSIBLE PARKING

One in seven Ontarians has a disability, and not all disabilities are visible. Be mindful of accessible parking spots. If you park next to an accessible parking space, don't park over the yellow-striped access aisles. They provide additional space for those with disabilities to get in and out of vehicles with ease. Drive slow when you are near accessible parking areas and close to building entrances.






Registering second units (basement apartments) with the City ensures that they are safe, legal and livable. It helps the City provide the unit with its own municipal address. This information is shared with Brampton Fire, in case of an emergency, they will know there is a second unit in your house before they arrive. This can save precious seconds in a life-or-death situation. The registry is also available on the City's website allowing residents to confirm if a property is legally registered. For illegal second units, fines could go up to \$25,000.



The City welcomes the expansion of more postsecondary opportunities including the budget announcement from the Provincial government to provide financial support for the development of a new institute of medical education in Brampton in partnership with Ryerson University.

Brampton continues to work on bringing a comprehensive university to the city. This is important because training and reskilling individuals with the most relevant skills and capabilities for jobs of the future will ensure our economy's resilience. In summer 2020, the City released critical components from its BramptonU proposal, including Academic, Governance, and Economic models for the development of BramptonU. The City has continued to build on stakeholder engagement, specifically with local businesses, through workshops to ensure there is awareness of the BramptonU project and determine how local stakeholders might become further involved in the development of the university. Currently the City continues to advocate to the Province to legislate BramptonU into existence by passing the Brampton University Act and discuss what the best path forward to doing so looks like.

FAIR DEAL FOR BRAMPTON



VIRTUAL TRUCKING TOWN HALL

In March 2021, Councillor Dhillon organized a virtual Trucking Town Hall in collaboration with Peel Regional Police and industry specialists, in order to address the needs of commercial truck drivers and business owners. Twelve per cent of all jobs in Brampton are related to trucking and logistics. Specialists from the industry included: Peel Police Crime Units, the Toronto Trucking Association, the Ontario Trucking Association, and the Insurance Bureau of Canada, all of whom were asked to give presentations. The event provided attendees with an opportunity to learn safety and prevention tips from panelists, as well as ask any questions. The Town Hall was the first of its kind and was deemed a success as panelists and hosts confirmed the event would be held on a regular basis.





WARD 9 AND 10 PARKS AND TRAIL PROJECTS

Councillor Dhillon has been consistently advocating for improvements to our local parks since first taking office. He has worked hard alongside City staff to clean up, refurbish, and remodel parks throughout wards 9 and 10. BLOOD DRIVE WITH CANADIAN BLOOD SERVICES

NEW LONG-TERM CARE HOME

Councillor Singh is happy to share that a new long-term care facility has been approved in wards 9 and 10! 160 beds have been allocated for this facility, which will be located at the intersection of Sandalwood Parkway and Fernforest Drive. Councillor Singh is thankful to our Provincial Government for approving this application. This facility will provide inclusive and quality health care to senior residents. The aim of this long-term care facility is to provide a brand new, culturally-sensitive, experience for seniors in Brampton. We are hoping for more facilities similar to this one as the years go on. Brampton is a mosaic and each community's unique experience will always be celebrated in our City.

SAVE MAX SPORTS CENTRE RENOVATIONS

(formerly Brampton Soccer Centre)



To better serve the needs of the community, the City has been working to transform part of the Save Max Sports Centre outdoor site into a yearround multi-sport venue. Amenity upgrades include:

- two outdoor multi-sport fields have been changed from natural to artificial turf, allowing for extended play season, as well as making the fields suitable for a variety of sports
- LED lights are being added to both fields to allow extended hours of use, while reducing glare and improving energy efficiency

- a seasonal dome is being built over one field, which will cover the field from November to April each year (allowing for usage over the colder months)
- a pavilion building is being added near the new dome to provide change room and washroom facilities for field users
- a straight running track is being incorporated into the dome area

Construction is nearing completion. The new facility is expected to be ready by Summer 2021, and the dome is expected to be installed in November 2021.
