COVID-19 UPDATE

Let's keep going toward full vaccination of Brampton residents - we are reaching important milestones in the collective fight against COVID-19, including good progress on first and second dose coverage, but we are not done yet. For the best protection, all eligible Brampton residents need to get fully vaccinated - this means taking the first step by getting a first dose and showing up for a second shot when eligible.

Brampton's case counts continue to decline thanks to your ongoing efforts! As of early July, 34.4% of Brampton residents have received at least one dose and 33% are fully vaccinated. Peel Public Health launched the "Real Peel, Real Voices" campaign that shares authentic and relatable stories from diverse Peel residents and local community leaders as vaccination ambassadors. HEAT WARNING SAFETY TIPS

When temperatures are over 31°C or humidity is high, heat warnings are issued. Remember to:

- Avoid strenuous activities between 10 am and 4 pm when it's the hottest
- Eat well-balanced, light, regular meals and drink plenty of water

- · Never leave children or pets alone in a parked car
- · Check on seniors, young children and those who may be vulnerable

WATERMAIN, SANITARY SEWER REPLACEMENT, ROAD REPAIRS AND RESURFACING PROJECT:

The Region of Peel is expecting to begin construction of a watermain and sanitary sewer replacement project in September 2021 which is necessary to address aging infrastructure. The Region of Peel and the City of Brampton will work together to keep everyone informed and aware of this work and we appreciate your patience as this necessary work is completed. Bylaw & Property Standards

Contractors are now required to complete a training course to get licenced through the City to discourage illegal construction on driveways. If you are looking to widen your driveway to create more parking space or beautifying with paving or stones, please check with the City to ensure you are not violating any by-laws.

As of June 2021, By-law Enforcement staff have resumed investigations into complaints of illegally widened driveways and have reinstated parking enforcement of all timed offences. Learn more at **brampton.ca/drivewaypaving**





Automated Speed Enforcement (ASE)

Last year, Brampton was one of the first municipalities in Ontario to implement Automated Speed Enforcement (ASE) systems in the city. ASE cameras work in conjunction with other traffic calming measures including speed display boards, the expansion of Community Safety Zones (CSZ) and the continuous collaboration with Peel Regional Police to increase speed compliance, alter driver behaviours, and raise public awareness on the need to slow down. One of the most effective ways to deal with aggressive driving on local roadways is the Road Watch Program. The Road Watch program is a co-operative effort by the municipalities within the Region of Peel and Peel Regional Police, giving residents the opportunity to report dangerous and aggressive drivers. The City of Brampton has 50 ASE cameras that it plans to rotate around 200 Community Safety Zones annually. ASE's have proven to be a great success and several roadways have experienced significant speed reductions. For example, Main St South (North of Frederick) has seen a reduction of 17.85km/hr and Ray Lawson Blvd (West of Berkingdale Crt) has reduced by 10.69km/hr.

ASE Camera locations in Ward 3 & 4

Although some locations appear to have had only a minimal impact they have been effective in dealing with sporadic speeding concerns in the area, and we will continue to work towards reducing speeds in these neighborhoods. Cameras will eventually be relocated, in order to address concerns on other roadways in Wards 3 & 4, and will continue to be rotated on a fixed schedule, eventually returning to the original locations.

- ★ Do not park your vehicle on the street between 2 am and 6 am or for more than 3 hours
- Do request a parking consideration to park on the street for up to 14 days each year, per vehicle licence plate
- Do keep sidewalks clear. When vehicles overhang the sidewalk, they can be an obstacle and unsafe for others who walk or use a stroller on sidewalks
