Notice of Intent to Amend Business Licensing By-law 332-2013 Increase to Various Business Licensing Fees in 2018

The City of Brampton intends to amend Business Licensing By-law 332-2013 to increase various business licence fees as of January 1, 2018, by three (3) percent, rounded up to the nearest dollar. The proposed licence fee increase is based on a review of similar business licence fees in other municipalities as well as a general increase to the Consumer Price Index since the fees were last established in January 2016.

A table of the current and proposed business licence fees is attached to this public notice.

City Council will consider this matter at its meeting on Wednesday, November 22, 2017 at 9:30 a.m.
