Notice of Hearing Brampton Committee of Revision

Regarding Special Charges for Local Improvement Work under Ontario Regulation 586/06 of the *Municipal Act, 2001* - Construction of "Noise Attenuation Barriers" (Noise Walls) on City Property affecting:

14 and 16 Madrid Crescent Southwest Corner of Bramalea Road and North Park Drive

The Brampton Committee of Revision will hold a public meeting to hear delegations regarding the City's intention to impose a special charge for local improvement works constructed on specific properties in the City. The meeting is scheduled for:

Tuesday, February 15, 2022, at 3:00 p.m. Council Chamber, 4th Floor, Brampton City Hall 2 Wellington Street West, Brampton ON L6Y 4R2

(Note: this will be a virtual meeting given current COVID pandemic public gathering limitations)

The Committee of Revision meeting is held in accordance with Ontario Regulation 586/06, Municipal Act, 2001.

The purpose of the Committee of Revision meeting is to hear objections to the proposed special charges, or the accuracy of the frontage measurements used to calculate the special charges and any other complaint that persons may make that is within the jurisdiction of the Committee of Revision, as set out in Ontario Regulation 586/06, with respect to the following constructed works:

Construction of a "Noise Wall" on the City right-of-way at the southwest corner of Bramalea Road and North Park Drive, affecting properties municipally known as 14 and 16 Madrid Crescent

In accordance with Ontario Regulation 586/06, any person who owns a lot to be specifically charged may object to a special charge, by filing an objection with the City Clerk's Office, at the address below, setting out the objection and the reasons in support of the objection. Affected persons wishing to file an objection and/or make a representation to the Committee of Revision must file their objection with the City Clerk's Office no more than 7 days prior to the Committee meeting (by Tuesday, February 8, 2022, prior to 4:30 p.m.).

Copies of information regarding these local improvements and special charges are available from the City Clerk's Office at the address below, during regular business hours.

In consideration of the current COVID-19 public health orders prohibiting large public gatherings and requirements for physical distancing between persons, in-person attendance at this meeting will be restricted. The meeting will be conducted through a virtual meeting platform with electronic participation enabled for meeting participants.
