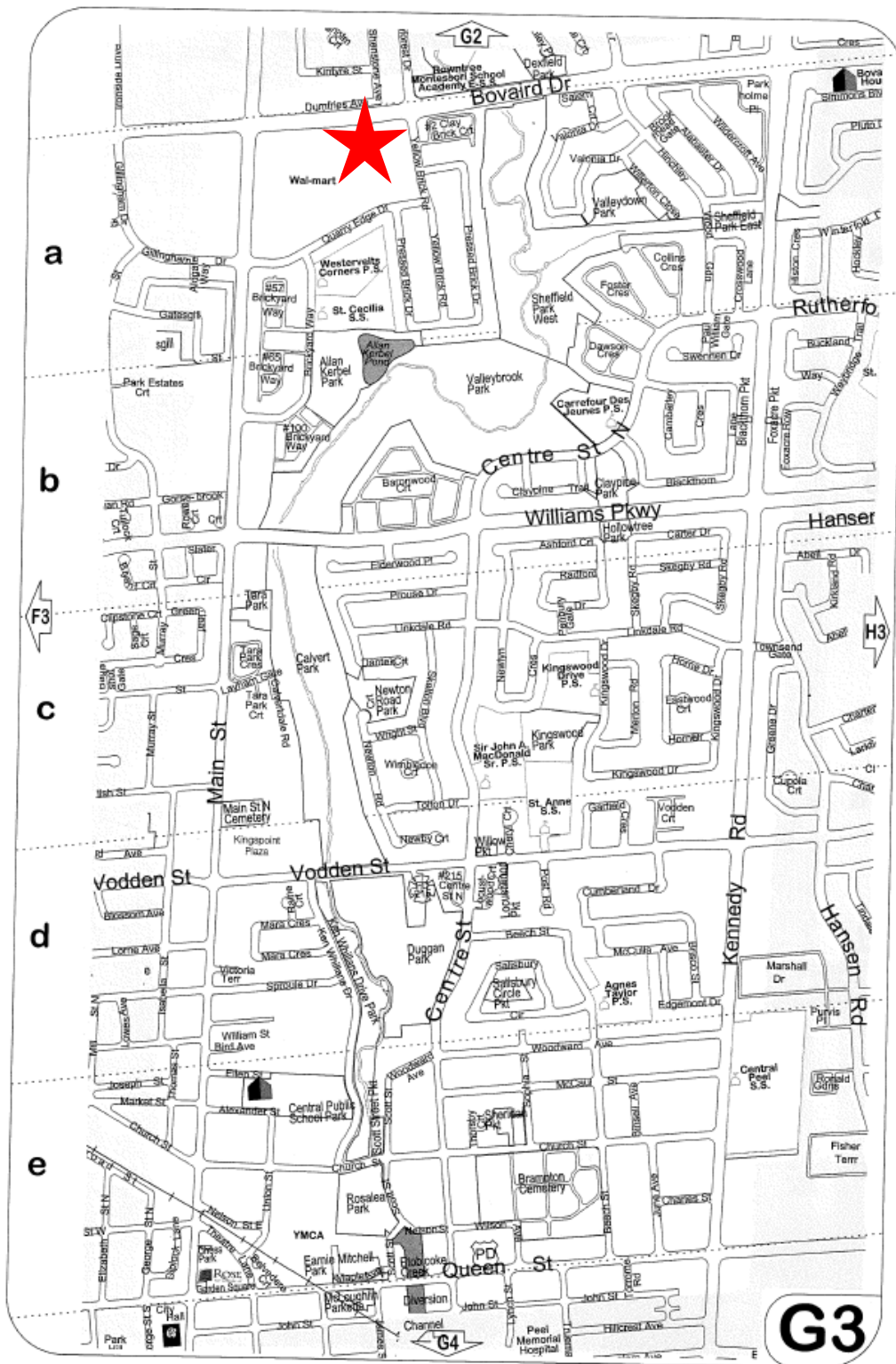

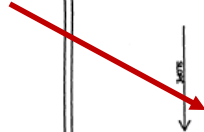

G-1b Mural

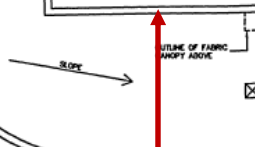

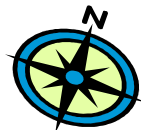

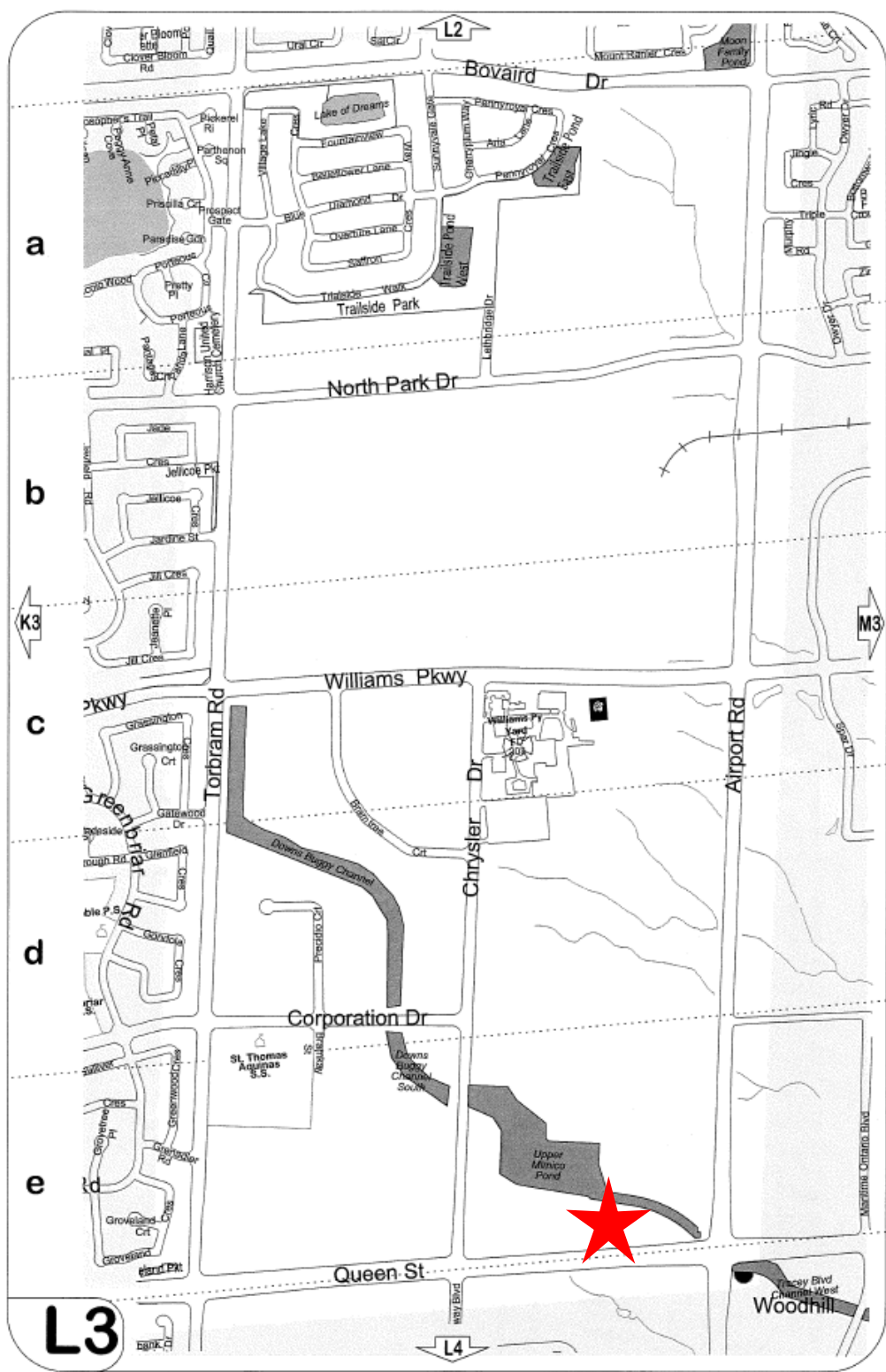

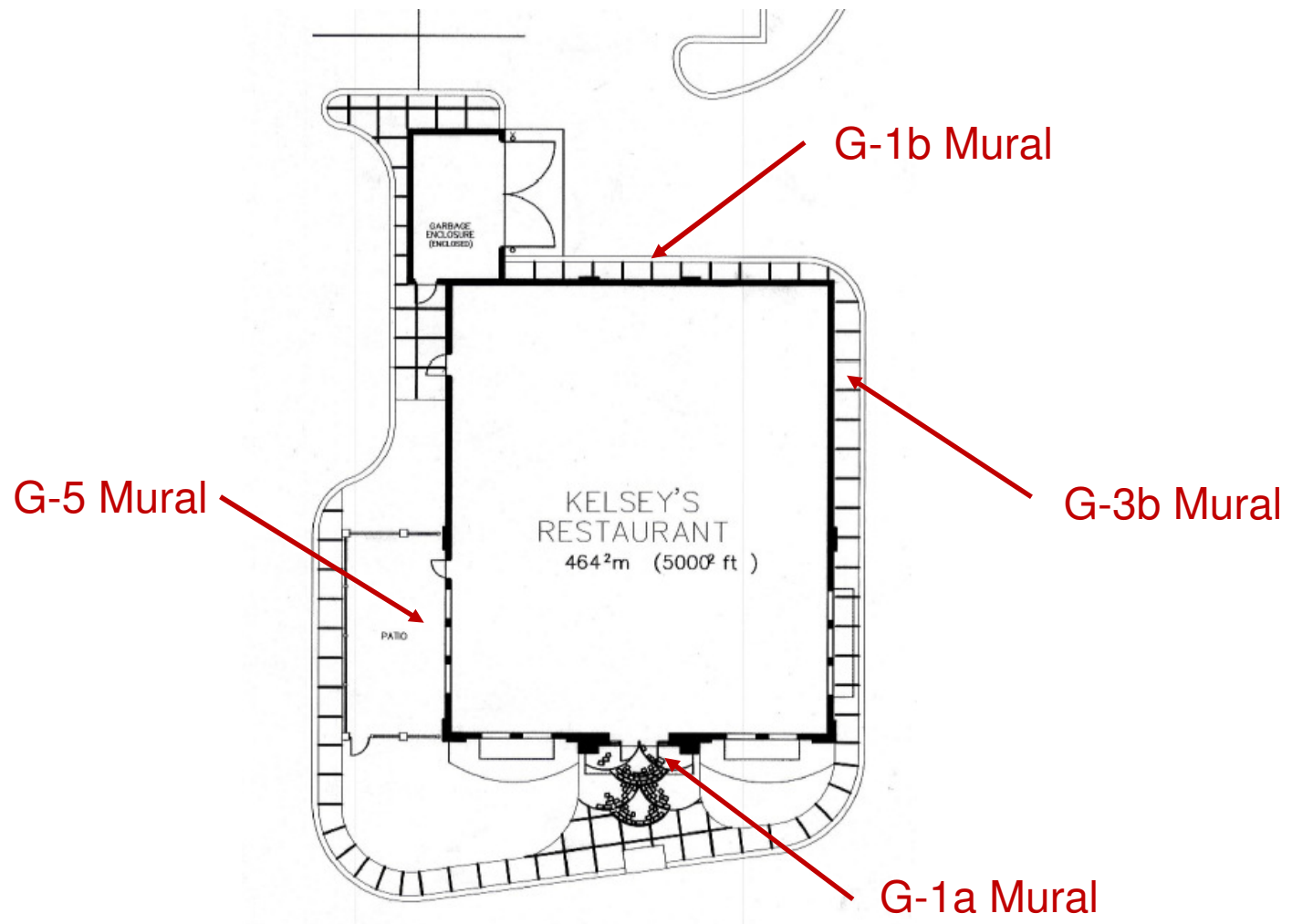

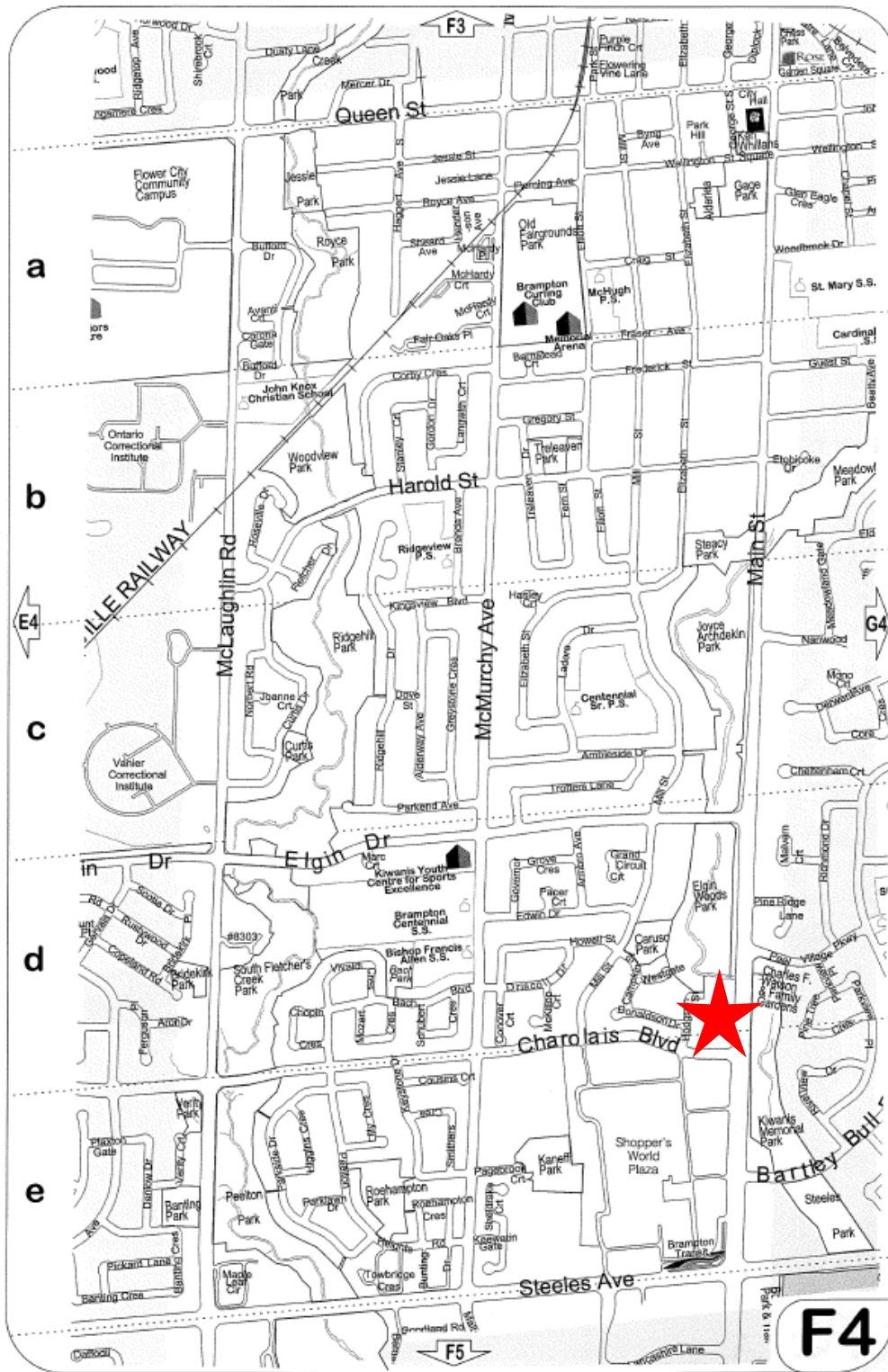

 Site Plan



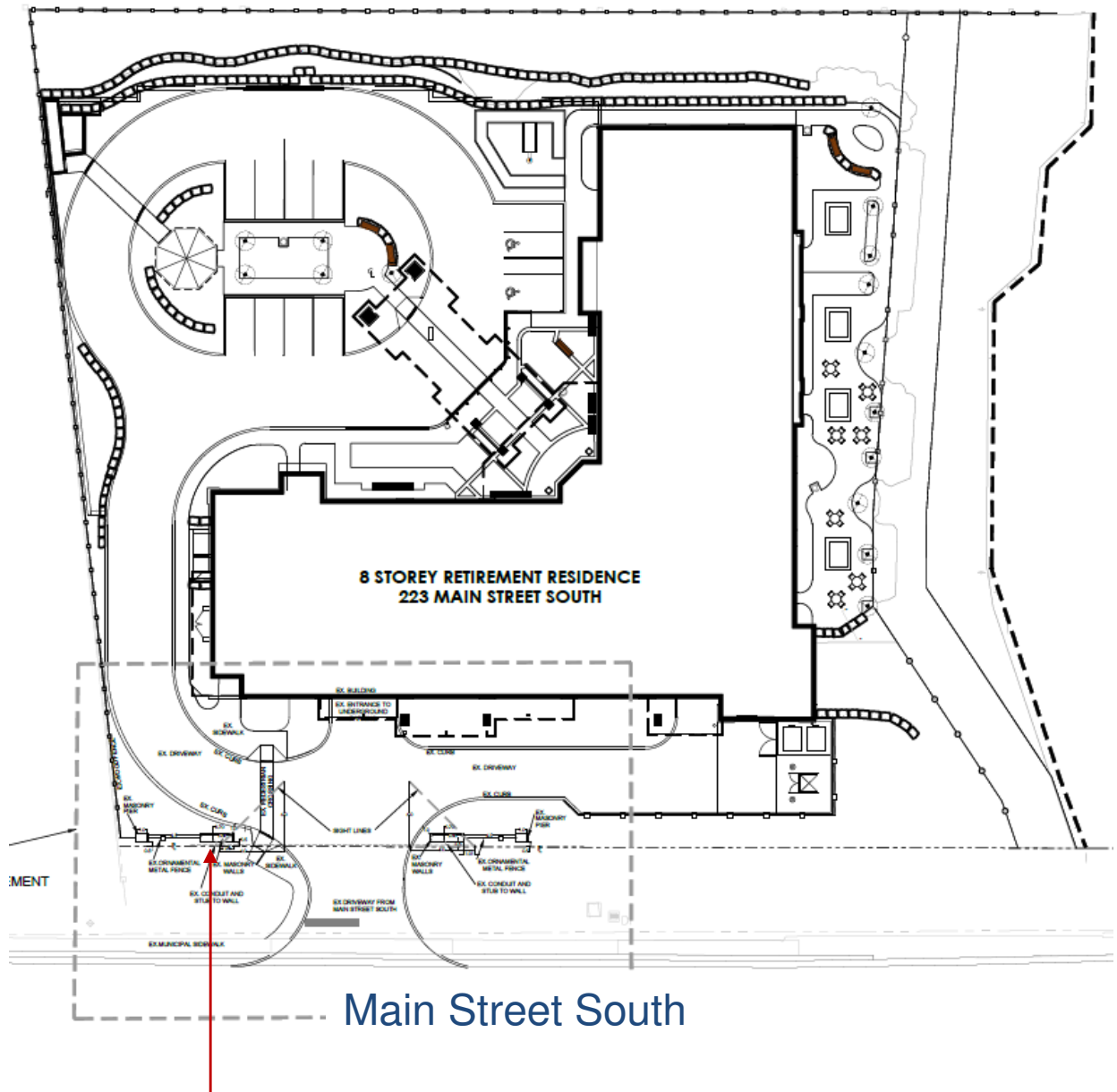

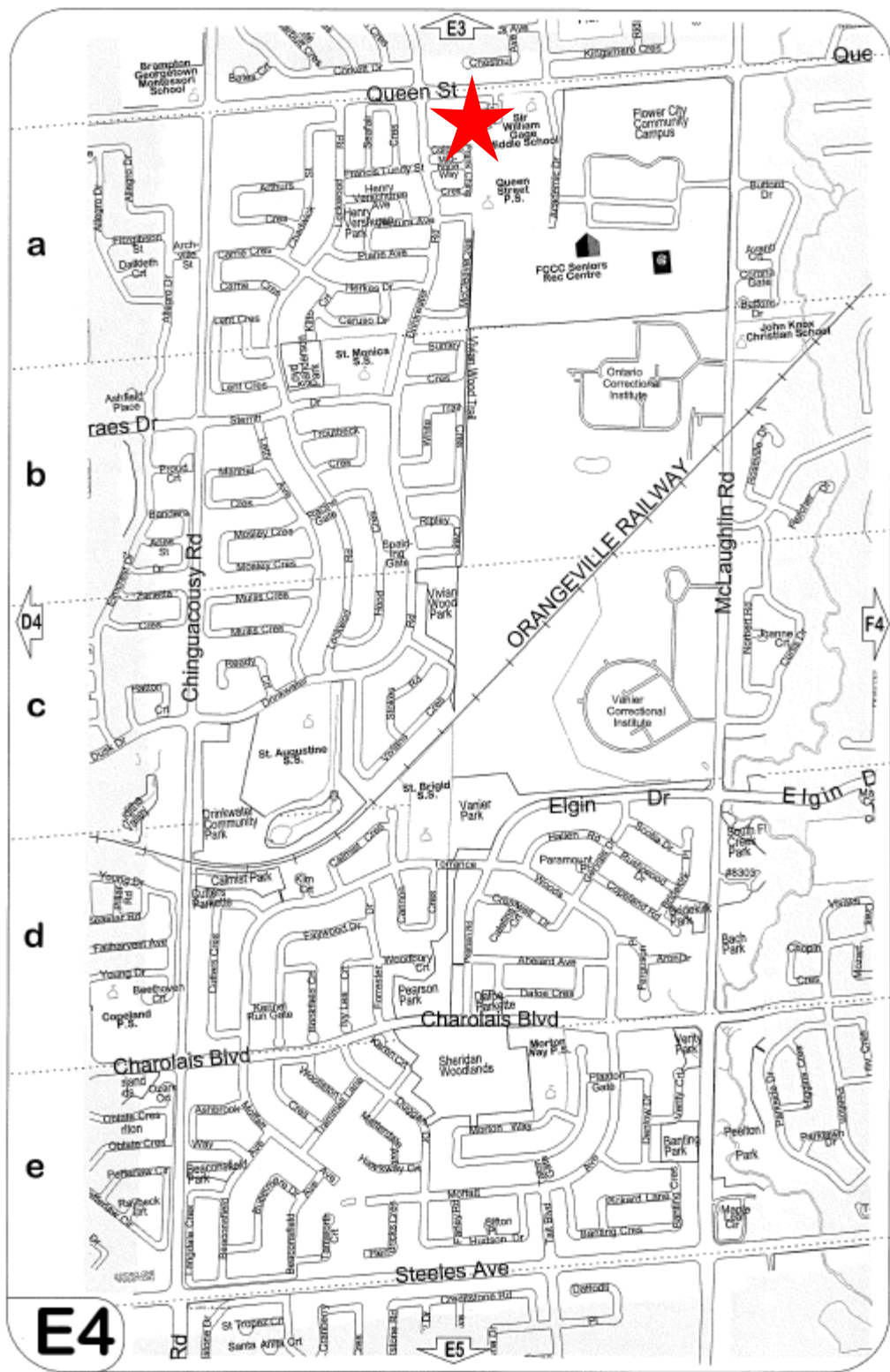

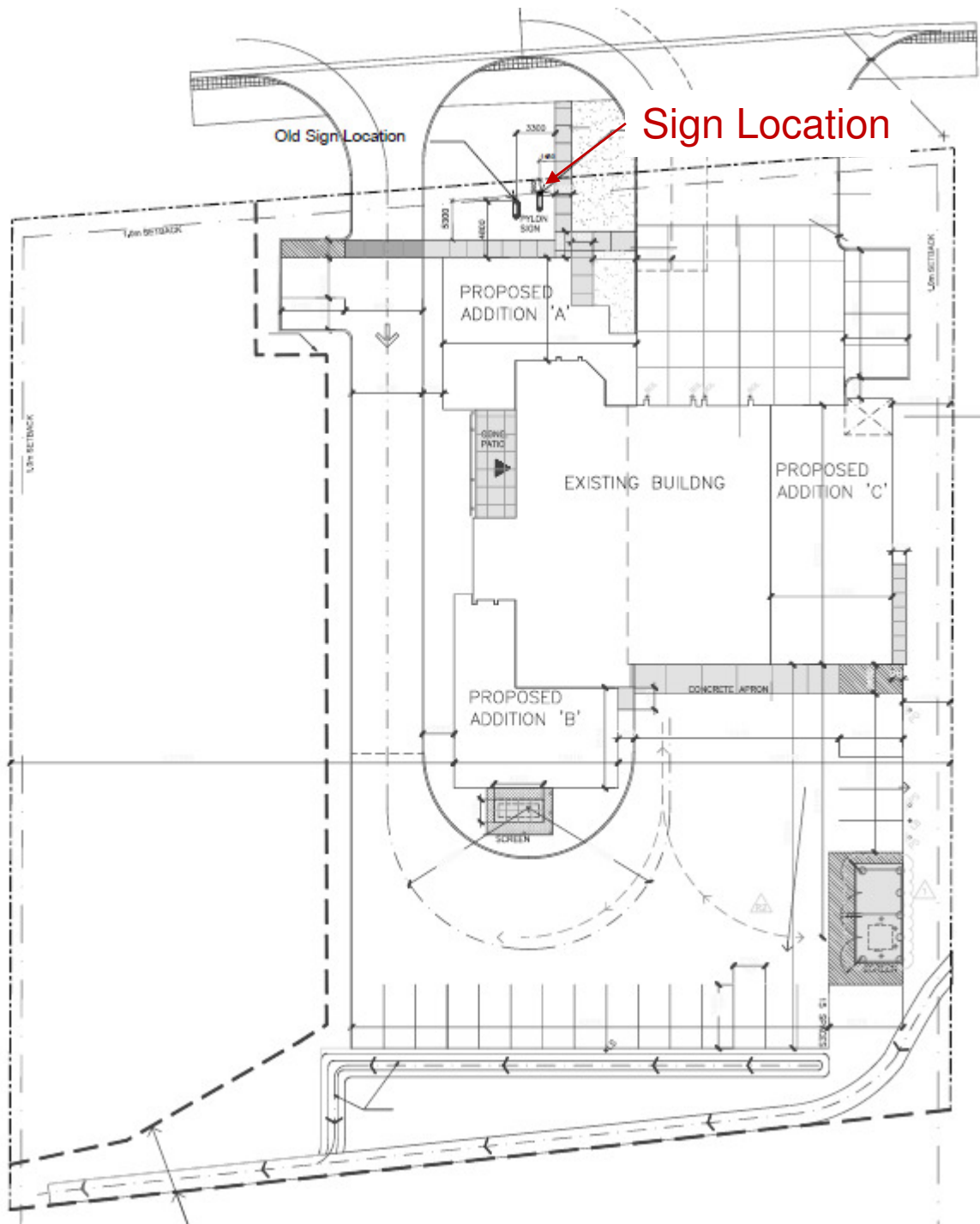

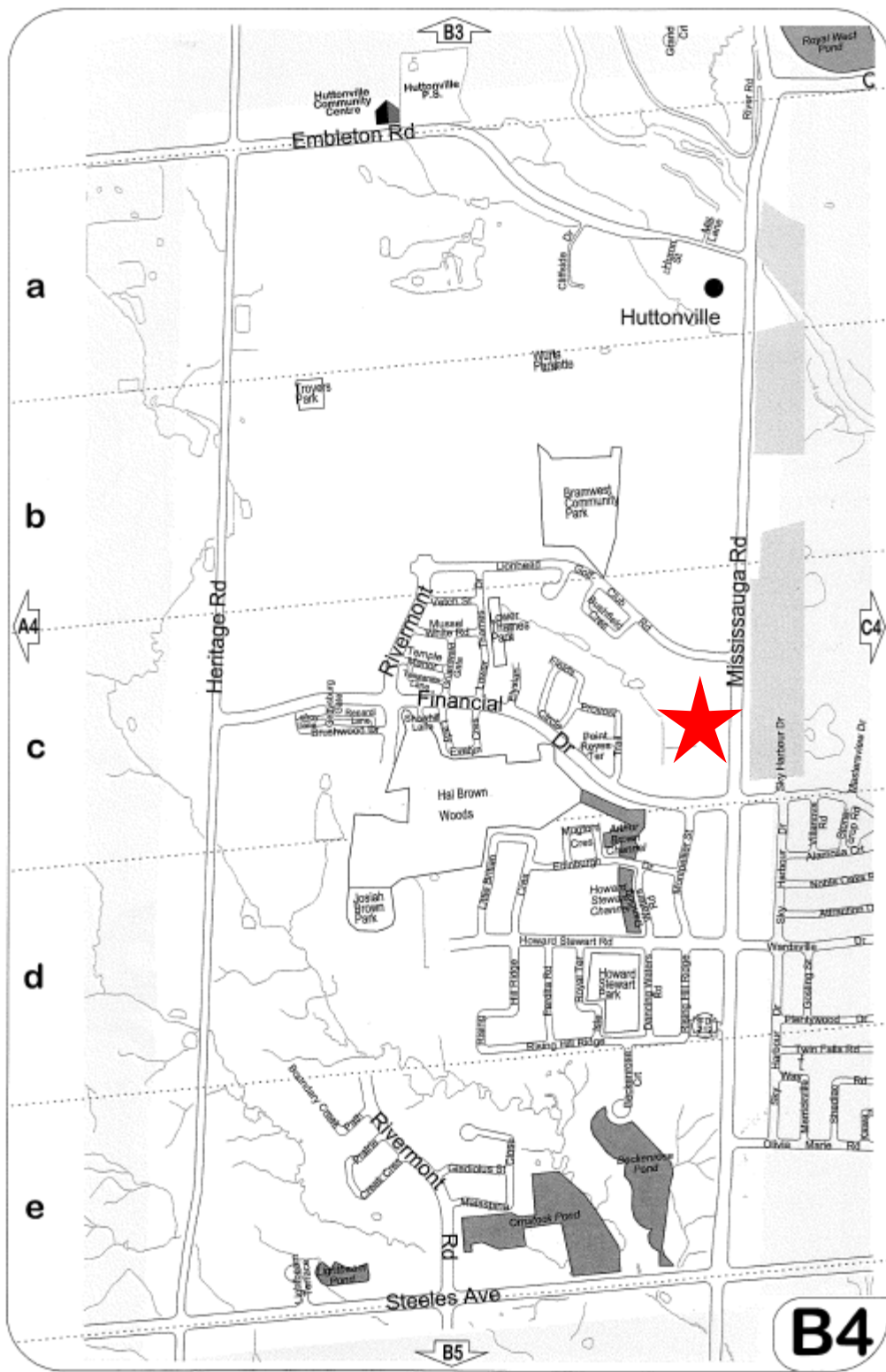

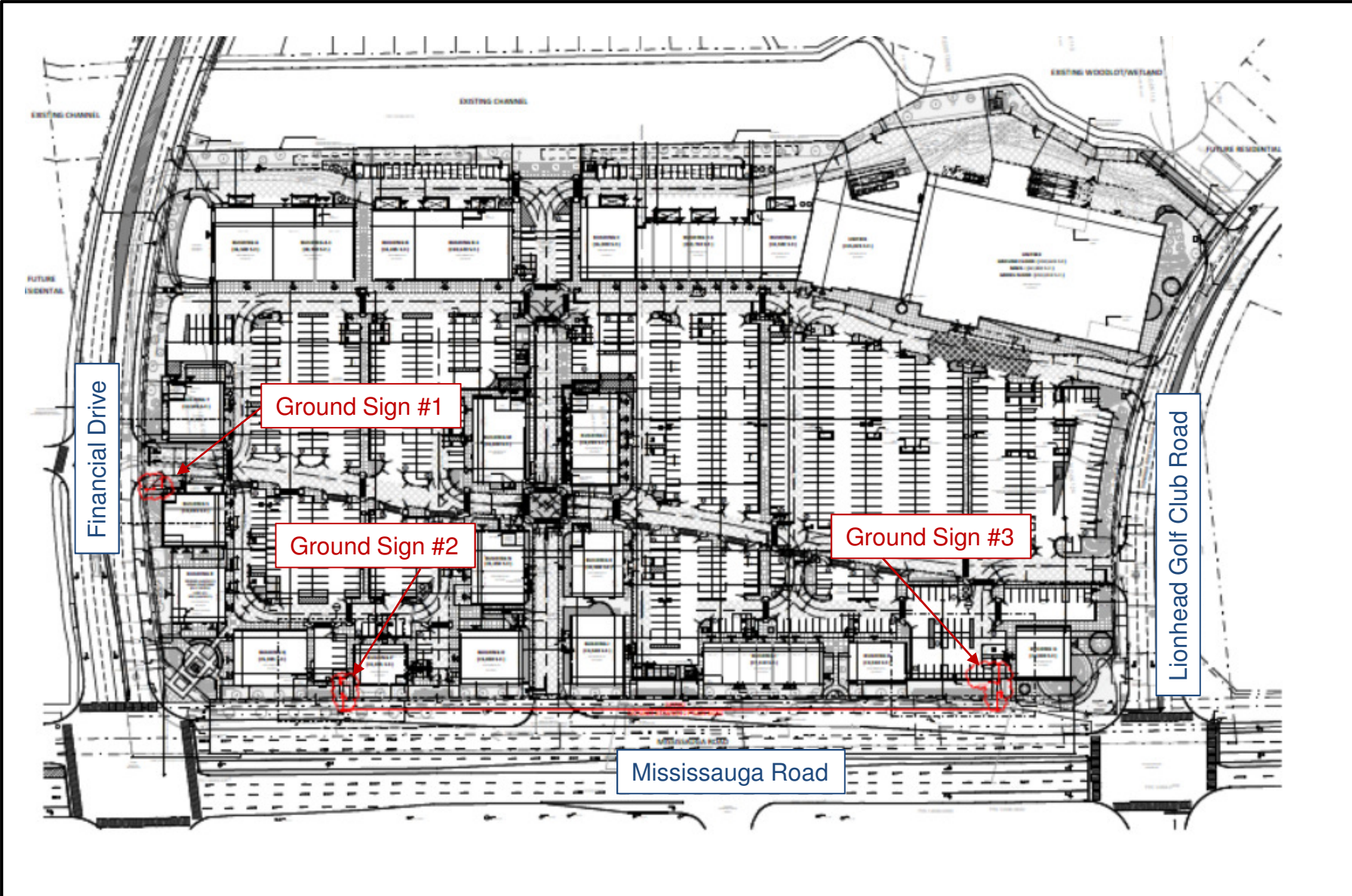
