A public meeting with respect to the above referenced development proposal will be held at the September 14th, 2020 Planning and Development Committee meeting. The notice for the public meeting is enclosed and will inform you of the details of the proposal.





Purpose and Effect

The purpose of the application is to create a Plan of Any person may express their support, opposition or Subdivision with three townhouse dwelling blocks, an amenity space block, a block for parking and a private laneway with access from Bramalea Road. The development ultimately proposes 15 townhouse units in a common element condominium.

An Official Amendment and Zoning By-law Amendment application was approved in January 2019 to permit the proposed townhouse development. This Draft Plan of Subdivision application is required to establish the blocks for the development.

For more information about this matter, including information about preserving your appeal rights contact the City Planner identified in this notice.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.

Important Information about making a submission


If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
