A public meeting with respect to the above referenced development proposal will be held at the June 8th, 2020 Planning and Development Committee meeting. The notice for the public meeting is enclosed and will inform you of the details of the proposal.



Purpose and Effect

The purpose of the Zoning By-law Amendment application is to permit the lands to be developed for an industrial business centre consisting of office and warehouse distribution uses, storm ponds, roads, and to protect the environmental features.

The lands subject to this application are located on both the east and the west sides of Coleraine Drive, south of Countryside Drive. A previous Public Meeting was held for it on February 2, 2015. Since that public meeting, the applicant has amended the application to add two newly acquired properties located on the east side of Coleraine Drive totaling 9.4 hectares (23.4 Acres). The addition of these lands now increases the overall land holdings to about 138 hectares (341 acres). This public meeting is being held for these two additional properties.



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

For more information about this matter, including information about preserving your appeal rights contact the City Planner identified in this notice.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment, enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
