Purpose and Effect


The purpose of the application to amend the Zoning Bylaw and for a Draft Plan of Subdivision is to permit a residential development with single detached residential dwellings. It proposes to change the zoning from 'Agricultural (A)' to zones permitting single detached residential dwellings, an open space zone, and a floodplain zone.

Details of the proposal include:

- 20 lots for single detached residential dwellings;
- Two residential part blocks to be combined with two existing part blocks in the adjacent subdivision;
- The extension of two public roads Porter Creek Hollow and Vernosa Drive; and,
- Open space blocks, a woodlot block, and two vista blocks.

If you have received this notice as an owner of a property and the property contains <u>7 or more</u> <u>residential units</u>, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


For more information about this matter, including information about preserving your appeal rights contact the City Planner identified in this notice.
