Purpose and Effect

The purpose and effect of the application is to amend the Zoning By-law to permit two high-rise residential towers of 30 storeys and 33 storeys in height joined by a shared 5-storey podium. The current Zoning By-law permits building heights of 89m, and an FSI of 6.15, whereas the requested Zoning By-law amendment would include the following details:

- To permit a total of 704 residential units;
- To permit 51,025 sq.m. of residential gross floor area and a floor space index (FSI) of 6.86: and.
- To provide four levels of underground parking consisting of 644 spaces with 19 parking spaces provided at-grade.

Supporting studies and drawings that have been submitted with the application are available on the City's website under Current Development Applications on the Planning and Development page.



If you have received this notice as an owner of a property and the property contains <u>7 or more residential units</u>, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

For more information about this matter, including information about preserving your appeal rights contact the City Planner identified in this notice.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning Bylaw or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
