

# **Purpose and Effect**

An application to amend the Official Plan and Zoning By-law that will facilitate the development of a 1.03 hectare site generally in accordance with the concept plan below. This application is proposing the following:

- An 8-storey retirement residence building with 200 units:
- Proposed floors 2 and 3 for memory care and assisted living residential units;
- Proposed floors 4 to 8 for independent living units:
- Proposed limited moves access from Mayfield Road and a full moves access from Callahan Court:
- Proposed 106 parking spaces both at-grade and underground.

The subject lands are located west of McLaughlin Road along Mayfield Road, and are municipally known as 2247, 2257 and 2271 Mayfield Road.



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

**Note:** In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law until at least 30 days after the date of a statutory public meeting.


# Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
