A public meeting with respect to the above referenced development proposal will be held at the April 12, 2021 Planning and Development Committee meeting. The notice for the public meeting is enclosed and will inform you of the details of the proposal.





#### **Purpose and Effect**

An application has been submitted to amend the Zoning By-law to permit the development of a single-storey, multi-unit warehouse building and associated office featuring the following:

- Warehouse building with gross floor area of 15,097 square metres (162,503 square feet)
- Accessory office space along the Dixie Road and Inspire Boulevard frontages
- A total of 169 parking spaces (including 8 accessible); 22 loading dock doors; 2 drive-in doors, and 4 loading spaces



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

**Note:** In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not enact a proposed Official Plan or Zoning By-law Amendment until at least 30 days after the date of a statutory public meeting.


#### Important Information about making a submission


If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
