# **Purpose and Effect**

An application to amend the Zoning By-law that will facilitate the draft plan of subdivision of a 4.06 hectare site generally in accordance with the concept plan below. This application is proposing the following:

- Proposed 35 single-detached dwellings;
- Proposed future townhouse block containing approximately 37 units fronting on McLaughlin Road;
- Blocks for residential reserves (0.18 hectares) proposed for the completion of the lots on the existing subdivision to the south and west of the site;
- Proposed drainage channel and new streets that provide access to McLaughlin road and adjacent subdivisions.

The subject land is located on the west side of McLaughlin Road, south of Mayfield Road and are municipally known as 10772 McLaughlin Rd.



If you have received this notice as an owner of a property and the property contains 7 or more residential units, the City requests that you post this notice in a location that is visible to all the residents, such as on a notice board in the lobby.

**Note**: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law until at least 30 days after the date of a statutory public meeting.


#### Important Information about making a submission


If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
