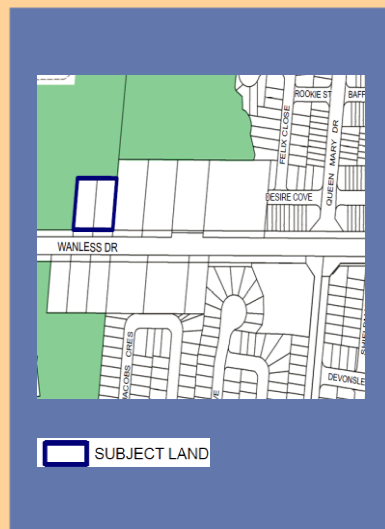

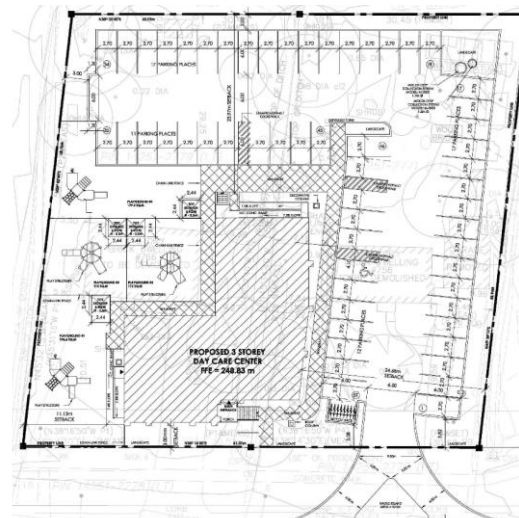
Application to Amend the Zoning By-law

Purpose and Effect

The subject property is located on the north side of Wanless Drive, approximately 334 metres (1,096 feet) west of the intersection of Wanless Drive and Queen Mary Drive, and is municipally addressed as 756 and 766 Wanless Drive. This application involves an Amendment to the Zoning By-law to permit the development of a 3 storey day care facility along with 57 parking spaces and outdoor play areas.

City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.

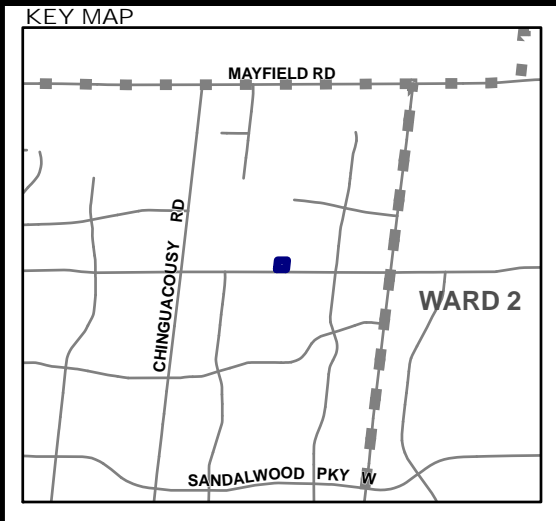

Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

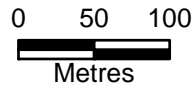

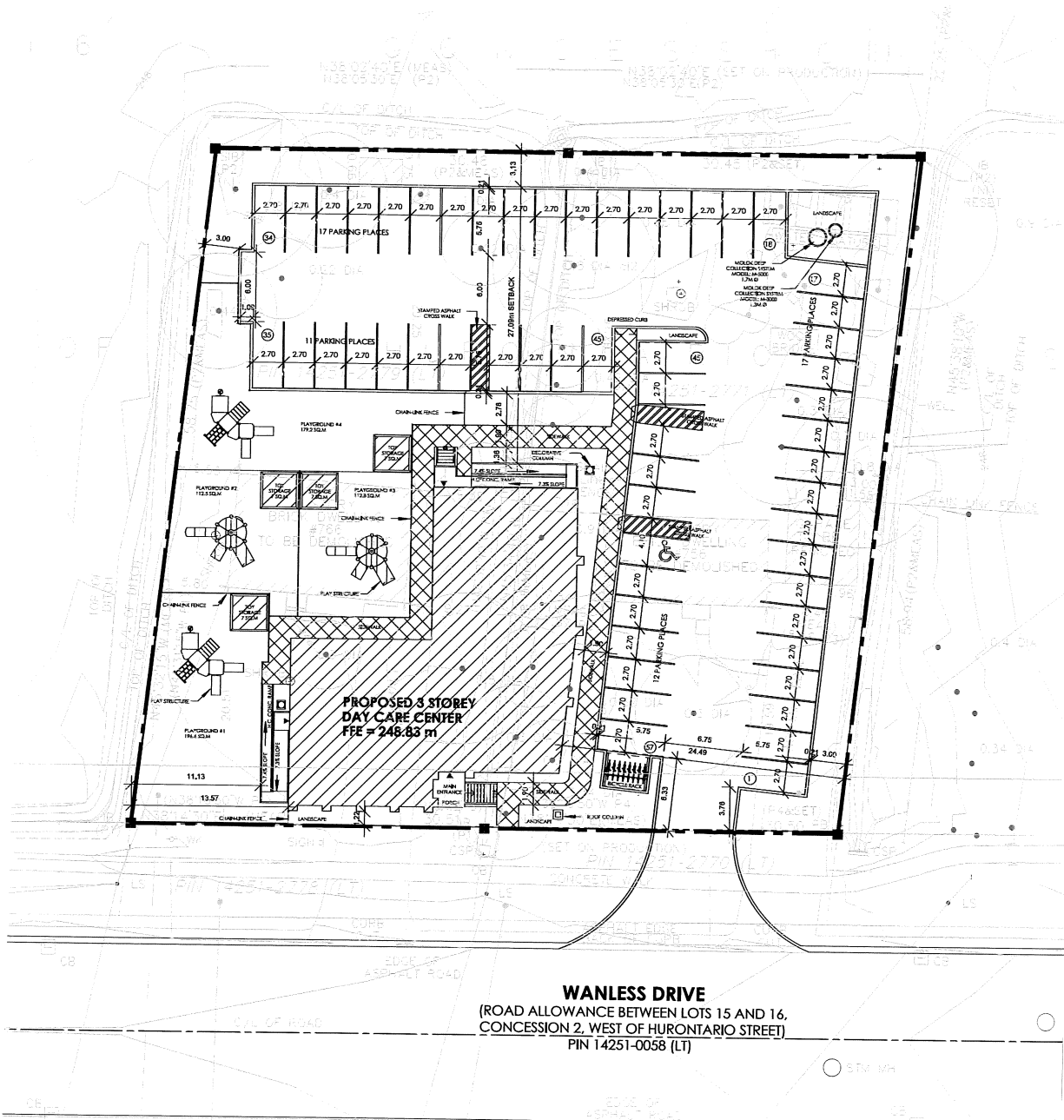


APPENDIX 2
