



Purpose and Effect

An application has been submitted to amend the Zoning By-law to further develop a 4.0 hectare site with two additional apartment buildings.

The property is located at 2 and 4 Hanover Road.

Proposal Highlights

- Two new apartment buildings 12 and 26 storeys in height;
- Maintain the two existing apartment buildings 18 and 22 storeys in height (605 units);
- · Creation of an additional 384 units;
- Proposed total number of units on the property: 989;
- A density of approximately 247 units/hectare; and,
- 1159 vehicular parking spaces.

Note: In accordance with Official Plan policy, a recommendation report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning Bylaw or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


