Purpose and Effect

Applications have been submitted to amend the Zoning By-law and for a Plan of Subdivision. The application is proposing the development of 50 townhouse units and 6 single detached dwelling lots.

The properties, 1265, 1279, 1303, 1323 Wanless Drive, are located on the south side of Wanless Drive between Creditview Road and Chinguacousy Road. The properties are zoned 'Agricultural (A)'. The Application to Amend the Zoning By-law Amendment is proposed to change the zoning to site specific 'Residential Single Detached F-10 (R1F)' and 'Residential Townhouse E-5.5 (R3E-5.5)' zones which would allow for the proposed single detached residential dwelling lots and the townhouse dwelling blocks.

Note: In accordance with Official Plan policy, a Recommendation Report will be prepared by staff and presented to a future meeting of the Planning and Development Committee and forwarded to City Council for a decision. City Council will not adopt a proposed Official Plan Amendment or enact a proposed Zoning By-law or approve in principle a plan of subdivision until at least 30 days after the date of a statutory public meeting.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk with respect to a proposed plan of subdivision, proposed official plan amendment or proposed zoning by-law amendment before the City gives or refuses to give approval to the draft plan of subdivision, or before a zoning by-law is passed, or before a proposed official plan amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Ontario Municipal Board; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.








