

## Notice of Passing of By-law 215-2022 to amend Interim Control By-law 306-2003

Date of Decision: September 26, 2022 Date of Notice: October 20, 2022 Last Date of Appeal: November 25, 2022

On the date noted above, the Council of The Corporation of the City of Brampton passed **By-law 215-2022**, to amend **Interim Control By-law 306-2003**, as amended, pursuant to an application by ARGO TFP BRAMPTON LTD. – Glen Schnarr & Associates Inc. – Ward 6 (File: OZS-2021-0052).

**The Purpose and Effect:** to remove a portion of lands from the Interim Control By-law 306-2003, as amended, that are subject to MZO order (O.Reg. 158/22).

**Location of Lands Affected:** located north of Bovaird Drive West, and west of Mississauga Road.

**Council Authority:** Council exercised authority to remove a portion of the lands within By-law 306-2003, as amended. By-law 306-2003, as amended, remains in force pursuant to Section 38(6.1) of the Planning Act.

**Obtaining Additional Information:** The lands subject to this by-law are shown on Schedule 'A' map included with this notice. When and How to File an Appeal: The Minister may, within 60 days after the date of passing of the amending by-law, appeal to the Tribunal by filing with the Clerk of the City of Brampton a notice of appeal setting out the objection to the amending by-law and reasons in support of the objection, no later than November 25, 2022, shown above, as the last date of appeal. 
To amend Interim Control By-law 306-2003, an Interim Control By-law applicable to Part of the Area Subject to Zoning By-law 270-2004, as amended, in order to remove a portion of lands subject to MZO order (O.Reg. 158/22)

The Council of The Corporation of the City of Brampton, in accordance with the provisions of the *Planning Act*, R.S.O. 1990, c.P. 13, hereby ENACTS as follows:

- 1. By-law 306-2003, as amended, ("ICBL 306-2003") is hereby, further amended as follows:
  - (1) The following is added as Section 1.25 (a)

"1.25 (a) All lands as amended by By-law <u>215</u>-2022 as shown on Schedule A as "Lands to be Removed from the FAA ICBL", are no longer subject to ICBL 306-2003, as amended."
