Notice of Intention to Amend Business Licensing By-Law 332-2013 Increase to Various Business Licensing Fees in 2020

On Wednesday, December 4th, 2019 at 9:30 a.m., in the Council Chamber, 4th Floor, City Hall, Committee of Council will consider amendments to increase various fees in the Business Licensing By-law 332-2013, as amended.

The proposed licence fee increase is based on a review of similar business licence fees in other municipalities as well as general increase to inflation, since the fees were last established in January 2018.
