# Introduction

Under the *Municipal Elections Act, 1996* (MEA), all candidates in the 2022 Municipal and School Board Election are required to file their Financial Statement – Auditor's Report – Form 4 with the City Clerk by the filing deadline (Friday, March 31, 2023, at 2 pm).

Candidates who withdrew their nomination are also required to file.

Candidates who fail to file their statement by the filing deadline may avoid automatic penalties if they file their statement during a 30-day grace period and provide the municipality with a \$500 late filing fee. The grace period ended on Monday, May 1, 2023, at 2 pm.

Candidate financial statements are posted on www.brampton.ca/bramptonvotes.

The MEA requires the City Clerk to prepare a report indicating which candidates complied with the filing requirements.

The MEA states the following:

Candidates' financial statements, etc.

- Section 88.25 (1) On or before 2 p.m. on the filing date, a candidate shall file with the clerk with whom the nomination was filed a financial statement and auditor's report, each in the prescribed form, reflecting the candidate's election campaign finances,
  - (a) in the case of a regular election, as of December 31 in the year of the election; and
  - (b) in the case of a by-election, as of the 45th day after voting day. 2016, c. 15, s. 60.

**Auditor** 

Section 88.25 (7) An auditor's report shall be prepared by an auditor licensed under the Public Accounting Act, 2004. 2016, c. 15, s. 60.

## Exception re auditor's report

Section 88.25 (8) No auditor's report is required if the total contributions received and total expenses incurred in the election campaign up to the end of the relevant period are each equal to or less than \$10,000. 2016, c. 15, s. 60.

## Documents filed after filing date

Section 88.25 (12) If the documents required to be filed under this section are not filed by 2 p.m. on the day that is 30 days after the applicable day for filing the documents, the clerk shall accept the documents only for the purpose of making the documents available under subsection 88 (9.1). 2016, c. 15, s. 60.

## Effect of default by candidate

- Section 88.23 (1) A candidate is subject to the penalties listed in subsection (2), in addition to any other penalty that may be imposed under this Act,
  - (a) if the candidate fails to file a document as required under section 88.25 or 88.32 by the relevant date;
  - (b) if a document filed under section 88.25 shows on its face a surplus, as described in section 88.31, and the candidate fails to pay the amount required by subsection 88.31 (4) to the clerk by the relevant date;
  - (c) if a document filed under section 88.25 shows on its face that the candidate has incurred expenses exceeding what is permitted under section 88.20; or
  - (d) if a document filed under section 88.32 shows on its face a surplus and the candidate fails to pay the amount required by that section by the relevant date. 2016, c. 15, s. 60.

#### Penalties

- Section 88.23 (2) Subject to subsection (7), in the case of a default described in subsection (1),
  - (a) the candidate forfeits any office to which he or she was elected and the office is deemed to be vacant; and

(b) until the next regular election has taken place, the candidate is ineligible to be elected or appointed to any office to which this Act applies. 2016, c. 15, s. 60.

# Clerk's report re filing requirements

Section 88.23 (4) The clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with section 88.25. 2016, c. 15, s. 60.

#### Same

- Section 88.23 (5) The report mentioned in subsection (4) shall be made available on a website or in another electronic format as soon as possible after,
  - (a) April 30 in the year following a regular election; and
  - (b) 90 days after voting day in a by-election. 2016, c. 15, s. 60.

#### Cessation of penalty

Section 88.23 (9) The penalties set out in subsection (2) for a default described in clause (1) (a) do not take effect if, no later than 2 p.m. on the day that is 30 days after the applicable day for filing the document, the candidate files the relevant document as required under section 88.25 or 88.32 and pays the clerk a late filing fee of \$500. 2016, c. 15, s. 60.
