If you do not request a review of this decision, you are required to pay the amount due by the due date. If payment in full is not received by the due date, a late payment fee of \$15.00 will be added to the amount due. If the amount due is in default for more than 15 days after the due date, a \$22.00 Ministry of Transportation Plate Denial Fee will be added to the amount due and the default in payment will be reported to the Registrar of Motor Vehicles which will result in the Registrar's refusal to issue validation of your vehicle permit or refusal to issue a vehicle permit until the amount due plus additional fees have been paid.
