

NOTICE OF STUDY COMMENCEMENT

Intermodal Drive and Watermain Extension to Gorewood Drive Municipal Class Environmental Assessment

The Study

The City of Brampton has initiated a Municipal Class Environmental Assessment (EA) Study for the extension of Intermodal Drive and Region of Peel watermain to Gorewood Drive. The recently-adopted Brampton Plan (2023) and the Airport Intermodal Secondary Plan (Area 4) identify the easterly extension of Intermodal Drive as a future east-west Collector Road traversing the upper midblock Gorewood properties and connecting to Gorewood Drive. The EA study will include evaluating capacity and active transportation needs, potential safety and operational issues towards achieving Vision Zero, population/employment growth and travel demand management.



The Process

The EA Study is being carried out in accordance with the planning and design process as outlined in the Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011, 2015 and 2023), which is approved under the Ontario *Environmental Assessment Act*. At this time, it is anticipated that this EA study falls under Schedule 'B' of the Municipal Class EA. The EA process includes completion of technical studies to determine existing conditions, development and evaluation of alternatives, an assessment of the impacts of the proposed extension, and development of a preferred design.

Public and stakeholder consultation is a key element of the Class EA process. Anyone interested in this EA Study is encouraged to provide comments. A Public Information Centre (PIC) will be held to offer an opportunity to review and provide input on the Study, including the alternatives, preferred design and anticipated impacts. Details of the PIC will be provided as the study progresses.

Thank you very much for your comments.

To clarify, this year, three (3) surveys were conducted by the natural environment team in support of this EA:


- Site Visit 1 on Friday, April 12, 2024: initial site visit, general habitat survey, trees visible in/from right of way surveyed for general wildlife use, potential woodpecker nests and bat potential, incidental sightings.
- Site Visit 2 on Thursday, June 13, 2024: first Breeding Bird Survey, vegetation (ELC) survey, incidentals.
- Site Visit 3 on Thursday, July 4, 2024: second Breeding Bird Survey, incidental sightings.

The next version of the Natural Environment Report will be updated to reflect the multiple surveys conducted in 2024. Our apologies for the confusion.

The project team did not have access to the private properties, so surveys could only be conducted from the road right of way and not from private lands.

Once the preferred road alignment is confirmed, then the trees that need to be removed are expected to have a bat habitat suitability survey completed prior to their removal. A bat box will be installed to allow for habitat relocation, as needed, and trees identified for removal that are candidates for roosting/breeding will not occur during the bat roosting / bird breeding window (April 1st to Sept. 30th).

Tree replacements shall follow the City of Brampton Tableland Tree Assessment Guidelines (2023) which includes ratios in the order 10:1 for larger trees, as shown below. The project team is working closely with the City’s Forestry Department to introduce native and non-invasive species with a separation distance that will allow trees to grow to maturity in the boulevard space proposed within the road ROW.




