NOTICE OF STUDY COMPLETION

Municipal Class Environmental Assessment Arterial Roads within Highway 427 Industrial Secondary Plan Area (Area 47) - PART B

The Study

The City of Brampton (City), in partnership with the Region of Peel (Region), has completed two Municipal Class Environmental Assessment (Class EA) Studies for the following roads:

- North-South Arterial (A2), a new north-south arterial roadway from Mayfield Road to Major Mackenzie Drive/Regional Road
 50.
- Coleraine Drive from Mayfield Road to Arterial A2.

Part B

- East-West (E-W) Arterial, a new east-west minor arterial roadway from The Gore Road to Arterial A2.
- Clarkway Drive from Castlemore Road to Mayfield Road.
- Countryside Drive from west of Clarkway Drive to Regional Road 50 including possible realignment at Regional Road 50.

The Class EA Study for Part B has been completed. This notice is in relation to Part B only. The Class EA Study for Part A was completed in Fall 2022.

Recommended Improvements under Part B Include:

- New east-west 4-lane arterial roadway between The Gore Road and Arterial A2 to provide connectivity for future development lands between Countryside Drive and Castlemore Road.
- Widening of Countryside Drive to the south from west of Clarkway Drive to Regional Road 50 to limit impacts on existing residential property.
- · A realignment of the intersection at Countryside Drive and Regional Road 50 to improve turning visibility for drivers.
- Widening of Clarkway Drive evenly about the existing centre line from Castlemore Road to Mayfield Road. Further detailed assessment of any potential impacts to Clarkway Creek will be completed during the design stage for Clarkway Drive.

The Process

The Study for Part B was carried out in accordance with the requirements for 'Schedule C' projects as outlined in the Municipal

Engineers Association Municipal Class Environmental Assessment document (October 2000, as amended in 2007, 2011 & 2015), which is an approved process under the Ontario Environmental Assessment Act. The City of Brampton previously completed the Area 47 Transportation Master Plan Study, which fulfilled the requirements for Phases 1 and 2 of the Class EA process. The City, in partnership with the Region, has now completed Phases 3 and 4 of the Class EA process for Part B. Subject to comments received as a result of this Notice, and the receipt of necessary approvals, the City intends to proceed with the detailed design and construction for the recommended improvements under Part B.

Commonts Invitod

The planning, consultation and preliminary design process that was undertaken for Part B has been documented in the Environmental Study Report (ESR). The ESR will be available for public review on the project websites (Region and City) which can be accessed through the following link or scanning the QR codes for 30 calendar days starting on January 26, 2023 and ending on February 24, 2023.

In addition, a request may be made to the Ministry of the Environment, Conservation and Parks for an order requiring a higher level of study (i.e. requiring an individual/comprehensive EA approval before being able to proceed), or that conditions be imposed (e.g. require further studies), only on the grounds that the requested order may prevent, mitigate or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights. Requests on other grounds will not be considered. Requests should include the requester contact information and full name.

Requests should specify what kind of order is being requested (request for conditions or a request for an individual/comprehensive environmental assessment), how an order may prevent, mitigate or remedy potential adverse impacts on Aboriginal or treaty rights, and any information in support of the statements in the request. This will ensure that the ministry is able to efficiently begin reviewing the request.
