

Purpose and Effect

Brampton Brick Ltd. will present revised plans and new information regarding the Norval Quarry proposal.

The purpose of this information meeting is to share information with the public and to hear comments.

Proposal highlights:

- In 2008, Brampton Brick Ltd. submitted a rezoning application to permit the extraction of shale and related uses. The 34.9-hectare (86 acre) site is located on the east side of Winston Churchill Boulevard, north of Old Pine Crest Road, and is within the Greenbelt Plan.
- The proposed Norval Quarry requires approval of an aggregate licence by the Ministry of Natural Resources and Forestry.
- In January 2011, Brampton Brick Ltd. appealed its rezoning application to the Ontario Municipal Board (OMB). Council no longer has jurisdiction on the rezoning application.
- In September 2014, informed by three peer reviews undertaken by the City's consultants, and, based on input from the public and other stakeholders, City Council endorsed the staff recommendation not to support the rezoning application, as proposed.
- In May 2016, Brampton Brick Ltd. submitted revised/new materials and updated plans for the proposed Norval Quarry.
